

Chairman Roegner, Vice Chairman McColley, Ranking Member Craig, and members of the State and Local Government Committee:

I am testifying today in favor of SB22 as an Ohio resident deeply concerned about courses of action being taken under the current emergency powers and the dire effects it is having on all of us.

From the beginning we have been lied to. We were told by London Imperial College that potentially 2.2 million would die of COVID-19 in the U.S. That was obviously a scare tactic.

In a New England Journal of Medicine Dr. Fauci stated that the coronavirus mortality rate was “much closer to a very bad flu.” I can give you the link to that article, but it has been removed. The truth is being withheld.

Here are some of the facts:

- The best studies for the last 45 years have shown conclusively that face masks don't offer any protection for viruses
- Medical authorities suggest that masks are risky to the healthy
- The WHO and CDC have recommended that you NOT wear masks if you are NOT SICK
- The PCR tests taken in Tanzania showed blind samples from a goat, a sheep, and a pawpaw fruit to be positive for Covid-19.
- The Nobel Prize winning inventor of the PCR test said it should never be used for diagnosis because it was not designed for that
- The NY Times has reported confirmed studies that show 90% of the results of the PCR tests are false
- The CDC and FDA are admitting the tests are useless
- The “surge” and “spiking” of cases is due to the increased amount of testing on people who have no symptoms and are not sick
- The CDC's numbers if you analyze them reveal that of the over 200,000 reported deaths WITH COVID-19, only about 8,000 in the US reportedly died **FROM** COVID and the average age of those who died **WITH** COVID was 80 years old, and they had on average 2.5 other significant medical conditions

- The state lockdowns have caused extraordinary damage to people's lives which Dr. Anthony Fauci even calls "irreparable damage."
- The CDC and WHO do not recommend lockdowns
- A report by Principia Scientific reports a new study that concludes COVID-19 lockdowns are ten times more deadly than the actual COVID-19 virus in terms of years of life lost by American citizens
- A Stanford University study states more people would die from the effects of the lockdowns, social distancing and face mask usage than reportedly had died from the disease
- The CDC Directory compares rate of suicides and drug overdoses to COVID-19 deaths
- Almost 30,000 doctors and 450,000 others have signed a declaration in strong opposition to further lockdowns

I wrote a letter to the Editor of my local paper which they refused to publish. All I did was ask people to question the information given us by our media. I listed other sources giving statements by scientists and physicians which contradicted what the MSM was spewing. I could not believe that my hometown paper was now a tool being used to spread the lies.

The people of Ohio must have a voice. Our representatives must have the power to stand up for us. I praise your efforts which recognize that we have been manipulated by lies and the censoring of truth. I urge you to vote in favor of SB22.
