SYNOPSIS 42

Resident's guardian 43

R.C. 3721.60, conforming changes in R.C. 3721.61, 3721.62, 44
3721.63, and 3721.68 45

Throughout the bill, replaces reference to a resident's 46
"sponsor" with references to a resident's "guardian," with the 47
result that any person making decisions regarding an electronic 48
monitoring device on behalf of a resident be limited to a person 49
appointed by the probate court instead of an adult friend or 50
relative. 51

Prohibitions and penalties 52

R.C. 3721.61, 3721.68, and 3721.99 53

Prohibits the installation of a hidden electronic 54
monitoring device in a resident's room and imposes a \$100 fine 55
for the first offense, and a \$500 fine for each subsequent 56
offense. 57

Prohibits anyone other than the resident, the resident's 58
guardian, or law enforcement personnel from viewing or listening 59
to images displayed or sounds recorded by an electronic 60
monitoring device installed in a resident's room and provides 61

that a violation is a misdemeanor of the first degree.	62
Financial assistance	63
R.C. 3721.65	64
Specifies that assistance provided by the Department of Health with purchasing and installing electronic monitoring devices is financial in nature.	65 66 67
Disclosure	68
R.C. 3721.66	69
Requires long-term care providers to disclose the number of authorized electronic monitoring devices to the Department of Health during each survey of the facility instead of submitting an annual report.	70 71 72 73
