A RESOLUTION BY THE COUNCIL OF THE CITY OF HUBBARD, OHIO IN SUPPORT OF RENAMING BRIDGE NUMBER TRU 304 7.22 ON STATE ROUTE 304 -THE "PURPLE HEART VETERANS MEMORIAL BRIDGE".

WHEREAS, various bridges throughout Trumbull County have been renamed to honor the military men and women who selflessly served our country; and,

WHEREAS, the Council of the City of Hubbard wishes to formally support the renaming of bridge number TRU 304 7.22 to honor veterans who have received the Purple Heart Medal.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That Hubbard City Council and Administration hereby support renaming bridge number TRU 304 7.22 as the "Purple Heart Veterans Memorial Bridge"

SECTION 2: The Clerk of Council is hereby directed to forward certified copies of this Resolution to State Senator Sandra O'Brien.

SECTION 3: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.


