BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4729.40 of the Revised Code be	4
enacted to read as follows:	5
Sec. 4729.40. (A) In the case of a prescription that	6
authorizes a drug to be dispensed by refilling the prescription	7
one or more times and the total quantity or amount of the drug	8
that may be dispensed by filling and refilling the prescription	9
does not exceed a ninety-day supply of the drug, a pharmacist	10
who is filling or refilling the prescription may dispense a	11
quantity or amount of the drug that varies from the quantity or	12
amount of the drug that otherwise would be dispensed pursuant to	13
the prescription, but only if all of the following conditions	14
are met:	15

(1) The action taken by the pharmacist does not result in	16
a quantity or amount of the drug being dispensed that exceeds	17
the total quantity or amount that may be dispensed by filling	18
and refilling the prescription.	19
(2) The prescription is for one of the following:	20
(a) A maintenance drug to be taken on a regular, recurring	21
basis to treat a chronic condition;	22
(b) A drug to be taken on a regular, recurring basis to	23
<pre>prevent disease;</pre>	24
(c) A contraceptive.	25
(3) If the prescription is for a maintenance drug, the	26
patient has used an initial thirty-day supply of the drug, or a	27
ninety-day supply of the drug has previously been prescribed to	28
the patient, and the pharmacist determines, after consulting	29
with the patient, that the drug has stabilized the patient's	30
condition.	31
(4) The prescription is not for a controlled substance, as	32
defined in section 3719.01 of the Revised Code.	33
(5) The prescriber did not include "dispense as written"	34
or another phrase having a similar meaning on the prescription,	35
or, when issuing a prescription electronically or orally, the	36
prescriber did not specify that the quantity or amount of the	37
drug to be dispensed may not vary from the quantity or amount	38
specified in the prescription.	39
(6) In the exercise of the pharmacist's professional	40
judgment after consulting with the patient, taking the action	41
authorized by this section is appropriate for the patient.	42
(B) This section does not require a health care insurer,	43
