## A BILL

То	enact sections 3727.70, 3727.71, 3727.72,	1
	3727.73, 3727.74, 3727.75, 3727.76, 3727.77,	2
	3727.78, and 3727.79 of the Revised Code to	3
	provide for the designation of a lay person to	4
	provide after-care to a hospital inpatient and	5
	participate in discharge planning.	6

### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 3727.70, 3727.71, 3727.72,	7
3727.73, 3727.74, 3727.75, 3727.76, 3727.77, 3727.78, and	8
3727.79 of the Revised Code be enacted to read as follows:	9
Sec. 3727.70. As used in this section and sections 3727.71	10
to 3727.79 of the Revised Code:	11
(A) "Admission" means a patient's admission to a hospital	12
on an inpatient basis by a health care professional specified in	13
division (B)(1) of section 3727.06 of the Revised Code.	14
(B) "After-care" means assistance provided by a lay	15
caregiver to a patient in the patient's residence after the	16
patient's discharge and includes only the caregiving needs of	17
the patient at the time of discharge.	18

(C) "Discharge" means the discharge or release of a	19
patient who has been admitted to a hospital on an inpatient	20
basis from the hospital directly to the patient's residence.	21
"Discharge" does not include the transfer of a patient to	22
another facility or setting.	23
(D) "Guardian" has the same meaning as in section 2133.01	24
of the Revised Code.	25
(E) "Lay caregiver" means an adult designated under	26
section 3727.71 of the Revised Code to provide after-care to a	27
<pre>patient.</pre>	28
(F) "Lay caregiver designation" means the designation of a	29
lay caregiver for a patient as described in section 3727.71 of	30
the Revised Code.	31
(G)(1) "Patient's residence" means either of the	32
<pre>following:</pre>	33
(a) The dwelling that a patient or the patient's guardian	34
considers to be the patient's home;	35
(b) The dwelling of a relative or other individual who has	36
agreed to temporarily house the patient following discharge and	37
who has communicated this fact to hospital staff.	38
(2) "Patient's residence" does not include any of the	39
following:	40
(a) A hospital;	41
(b) A nursing home, residential care facility, county	42
home, or district home, as defined in section 3721.01 of the	43
Revised Code;	44
(c) A veterans' home operated under Chapter 5907. of the	45

Revised Code;	
(d) A residential facility, as defined in section 5119.34	47
of the Revised Code;	48
(e) A residential facility, as defined in section 5123.19	49
of the Revised Code;	50
(f) A hospice care program or pediatric respite care	51
program, as defined in section 3712.01 of the Revised Code;	52
(q) A freestanding inpatient rehabilitation facility	53
licensed under section 3702.30 of the Revised Code;	54
(h) Another facility similar to one specified in this	55
division.	56
Sec. 3727.71. (A) In the case of a patient who is at least_	57
eighteen years of age and not unconscious or otherwise	58
incapacitated at the time of admission, a hospital shall offer	59
the patient or the patient's quardian an opportunity to	60
designate a lay caregiver for the patient. The offer shall be	61
made after the patient's admission and before the patient's	62
discharge.	63
(B) In the case of a patient who is at least eighteen	64
years of age and unconscious or otherwise incapacitated at the	65
time of admission, a hospital shall offer the patient or the	66
patient's quardian an opportunity to designate a lay caregiver	67
for the patient. The offer shall be made after the patient	68
regains consciousness or capacity and before the patient's	69
discharge.	70

Sec. 3727.72. (A) If a patient or guardian makes a lay	71
caregiver designation, the hospital shall do both of the	72
<pre>following:</pre>	73

(1) To the extent the information is available, record in	74
the patient's medical record the lay caregiver's name, address,	75
telephone number, electronic mail address, and relationship to	76
<pre>the patient;</pre>	77
(2) Request from the patient or guardian written consent	78
to disclose the patient's medical information to the lay	79
caregiver in accordance with hospital policy and state and	80
federal law.	81
(B) If a patient or guardian declines to make a lay	82
caregiver designation, the hospital shall note that decision in	83
the patient's medical record and have no other obligation under	84
sections 3727.71 to 3727.79 of the Revised Code.	85
Sec. 3727.73. A patient or guardian may revoke a lay	86
caregiver designation at any time before the patient's discharge	87
by communicating that intent to hospital staff. After	88
revocation, a new lay caregiver designation may be completed in	89
accordance with section 3727.71 of the Revised Code.	90
Sec. 3727.74. (A) Except as provided in division (B) of	91
this section, a hospital that intends to discharge a patient, or	92
transfer a patient to another hospital or facility, shall notify	93
the patient's lay caregiver of that intent as soon as	94
practicable.	95
(B) Division (A) of this section does not apply if the	96
patient or guardian has not given the written consent described	97
in division (B) of section 3727.72 of the Revised Code.	98
Sec. 3727.75. (A) A hospital that intends to discharge a	99
patient shall, as soon as practicable, create a discharge plan	100
and review that plan with the patient or the patient's quardian.	101
If a lay caregiver designation has been made, the patient's	102

attending physician has determined that the lay caregiver's	103
participation in the review would be appropriate, and the lay	104
caregiver is available within a reasonable amount of time, the	105
hospital shall arrange for the lay caregiver to also participate	106
in the review. The review shall be conducted in accordance with	107
section 3727.76 of the Revised Code.	108
(B)(1) A discharge plan may include the following	109
<pre>information:</pre>	110
(a) A description of the tasks that are necessary to	111
facilitate the patient's transition from the hospital to the	112
<pre>patient's residence;</pre>	113
(b) Contact information for the health care providers or	114
providers of community or long-term care services that the	115
hospital and the patient or guardian believe are necessary for	116
successful implementation of the discharge plan.	117
(2) If a lay caregiver designation has been made and the	118
patient's attending physician has determined that the lay	119
caregiver is to have a role in the discharge plan, the discharge	120
plan shall include all of the following:	121
(a) The lay caregiver's name, address, telephone number,	122
electronic mail address, and relationship to the patient, if	123
available;	124
(b) A description of all after-care tasks to be performed	125
by the lay caregiver, taking into account the lay caregiver's	126
<pre>capability to perform such tasks;</pre>	127
(c) Any other information the hospital believes is	128
necessary for successful implementation of the discharge plan.	129
(C) An attending physician shall not be subject to	130

criminal prosecution or professional disciplinary action, or be	131
liable in a tort action or other civil action, for an event or	132
occurrence that allegedly arises out of the physician's	133
determination that a patient's lay caregiver should or should	134
not participate in the review of the patient's discharge plan.	135
Sec. 3727.76. (A) The review of a discharge plan that has	136
been created under section 3727.75 of the Revised Code shall be	137
conducted in a manner that is culturally sensitive to each	138
individual who participates in the review. In accordance with	139
state and federal law and if appropriate, the hospital shall	140
arrange for an interpreter to be present during the instruction.	141
(B) The review described in division (A) of this section	142
shall include the following components:	143
(1) If the patient's attending physician determines that	144
it is appropriate, a live demonstration of each task described	145
in the discharge plan performed by a hospital employee or an	146
individual under contract with the hospital to provide the	147
<pre>instruction;</pre>	148
(2) An opportunity for each participant to ask questions	149
and receive responses;	150
(3) Any other component the hospital believes is necessary	151
to ensure that each participant receives adequate instruction on	152
the tasks described in the discharge plan.	153
(C) The hospital shall document information concerning the	154
<pre>instruction provided under this section in the patient's medical</pre>	155
record. The information shall include the date and time the	156
instruction was provided and a description of the instruction	157
<pre>content.</pre>	158
Sec. 3727.77. (A) Sections 3727.70 to 3727.76 of the	159

Revised Code do not require a patient or guardian to make a lay	160
<pre>caregiver designation.</pre>	161
(B) A lay caregiver designation does not obligate any	162
<pre>individual to perform after-care.</pre>	163
(C) A lay caregiver designation or the absence of one	164
shall not interfere with, delay, or otherwise affect the	165
provision of health care to the patient.	166
Sec. 3727.78. It is the intent of the general assembly	167
that sections 3727.70 to 3727.77 of the Revised Code not be	168
<pre>construed to do any of the following:</pre>	169
(A) Interfere with the authority of a patient's attorney-	170
in-fact under sections 1337.11 to 1337.17 of the Revised Code or	171
a patient's proxy under sections 2135.01 to 2135.14 of the	172
Revised Code;	173
(B) Create a right of action against a hospital or an	174
employee, agent, or contractor of the hospital;	175
(C) Create a liability for a hospital or an employee,	176
agent, or contractor of the hospital;	177
(D) Limit, impair, or supersede any right or remedy that a	178
person has under any other statute, rule, regulation, or the	179
<pre>common law of this state;</pre>	180
(E) Alter the obligations of an insurer under a health	181
insurance policy, contract, or plan.	182
Sec. 3727.79. The department of health may adopt rules	183
pursuant to Chapter 119. of the Revised Code as necessary to	184
implement sections 3727.70 to 3727.78 of the Revised Code.	185
