BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 2108.18 and 2919.14 of the	4
Revised Code be amended to read as follows:	5
Sec. 2108.18. (A) Except as otherwise provided in division	6
(B) of this section, no person shall, for valuable	7
consideration, knowingly purchase or sell a part for	8
transplantation or therapy if removal of a part from an	9
individual is intended to occur after the individual's death.	10
(B) A person may charge a reasonable amount for the	11
removal, processing, preservation, quality control, storage,	12
transportation, implantation, or disposal of a part, except as	13
provided in section 2919.14 of the Revised Code.	14
Sec. 2919.14. (A) As used in this section:	15
(1) "Abortionist" means a person who performs or induces	16

an abortion.	17
(2) "Ambulatory surgical facility" has the same meaning as	18
in section 3702.30 of the Revised Code.	19
(3) "Person associated with the abortionist" means either	20
of the following:	21
(a) An individual who assists the abortionist in	22
performing the abortion, regardless of whether the individual is	23
<pre>employed by the abortionist;</pre>	24
(b) A private physician practice, professional	25
corporation, or ambulatory surgical facility to which either of	26
the following apply:	27
(i) The practice, corporation, or facility is owned or	28
operated by the abortionist and the abortion is performed there.	29
(ii) The practice, corporation, or facility employs or	30
contracts with the abortionist to perform the abortion.	31
(4) "Physician" has the same meaning as in section	32
2305.113 of the Revised Code.	33
(5) "Product of human conception" includes organs,	34
tissues, and cells.	35
(B)(1) No person shall experiment upon or sell the product	36
of human conception which that is aborted. Experiment does not	37
include autopsies pursuant to sections 313.13 and 2108.50 of the	38
Revised Code.	39
(2) No abortionist or person associated with the	40
abortionist shall financially benefit from or receive any type	41
of compensation for either of the following:	42
(a) Allowing a person who was not involved in the	43
