## A BILL

T	o enact sections 2923.51, 2923.52, 2923.53,	1
	2923.54, and 2923.55 of the Revised Code to	2
	generally ban the manufacture, sale, alteration,	3
	and public display of imitation firearms and the	4
	disguising of a firearm to make it resemble an	5
	imitation firearm.	6

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 2923.51, 2923.52, 2923.53,	7
2923.54, and 2923.55 of the Revised Code be enacted to read as	8

firearm, or other device that is so substantially similar in	17
overall appearance to an existing firearm as to lead a	18
reasonable person to perceive that the device is a firearm,	19

regardless of the color of the BB device, replica, or other	20
device.	
(C) "Public place" means an area open to the public,	22
including any of the following:	23
(1) A street, alley, sidewalk, driveway, or parking lot;	24

(A) Any imitation firearm legally manufactured in this state on or after December 19, 2018, shall 132 be accompanied, at the time of offer for sale in this state, by 133 a conspicuous advisory in writing as part of the packaging of 134 the imitation firearm to the effect that all of the following 135 136 apply: (1) The product may be mistaken for a firearm by law 137 enforcement officers or others. 138 (2) Altering the product to make it look more like a 139 firearm is dangerous and may be a crime. 140 (3) Brandishing or displaying the product in public may 141 cause confusion and may be a crime. 142 (B) To comply with division (A) of this section, the 143 conspicuous advisory may be, but is not required to be, affixed 144 to the imitation firearm. 145 (C) No person shall knowingly fail to comply with division 146 (A) of this section. 147 (D) Whoever violates division (C) of this section is 148 quilty of failure to provide imitation firearm warnings, a 149 misdemeanor of the first degree. 150
