### A BILL

То	enact section 4561.02 of the Revised Code to	1
	establish the Governing Board of the Ohio	2
	Aviation Hall of Fame and Learning Center for	3
	purposes of establishing the Hall and inducting	4
	persons into it.	

#### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4561.02 of the Revised Code be	6
enacted to read as follows:	7
Sec. 4561.02. (A) There is hereby created the governing	8
board of the Ohio aviation hall of fame and learning center	9
consisting of nine members who have a demonstrated interest in	10
Ohio aviation history. The governor shall appoint all members of	11
the board. Of the nine members, the governor shall appoint one	12
member to represent one major political party and another member	13
to represent the other major political party.	14
(B) The governor shall make initial appointments to the	15
board not later than January 1, 2018. Of the initial	16
appointments to the board, three shall be for a term ending	17

January 1, 2019, three shall be for a term ending January 1,	18
2020, and three shall be for a term ending January 1, 2021.	19
Thereafter, terms for all members shall be for three years, with	20
each term ending on the same day of the same month as did the	21
term that it succeeds. Each member shall hold office from the	22
date of the member's appointment until the end of the term for	23
which the member was appointed. Members may be reappointed. The	24
governor shall fill vacancies in the manner provided for	25
original appointments. Any member appointed to fill a vacancy	26
occurring prior to the expiration date of the term for which the	27
member's predecessor was appointed shall hold office as a member	28
for the remainder of that term. A member shall continue in	29
office subsequent to the expiration date of the member's term	30
until the member's successor takes office or until a period of	31
sixty days has elapsed, whichever occurs first. The governor may	32
reappoint a member to the board, but no member shall serve more	33
than two total terms.	
All members shall serve without compensation. The board	35
shall elect a chairperson from its membership. It shall meet at	36
least four times per year and shall keep a record of its	
proceedings, which shall be open to the public for inspection. A	37 38
written notice of the time and place of each meeting shall be	39
	40
sent to each member. A majority of the members of the board	
shall constitute a quorum.	41
(C) The board shall do all of the following:	42
(1) Commission a business plan for the establishment and	43
implementation of the Ohio aviation hall of fame and learning	44
<pre>center;</pre>	45
(2) Select a site for the Ohio aviation hall of fame and	46
learning center at the location of the "Triumph of Flight	47

Monument." If construction of that monument has not begun by	48
January 1, 2022, the board may select another temporary or	49
permanent location.	
(3) Conduct an annual induction ceremony at a location in	51
this state selected by the board. The board may induct only	52
residents of this state affiliated with the aviation or	53
aerospace industry. The board shall induct not more than five	54
persons per year.	55
(D) The Wright image group may provide any necessary staff	56
or services required by the board in the performance of its	57
duties.	58
(E) The board is not subject to sections 101.82 to 101.87	59
of the Revised Code.	60
(F) There is hereby created in the state treasury the Ohio	61
aviation hall of fame and learning center fund. The fund shall	62
consist of donations of money, grants, and money appropriated to	63
it by the general assembly. The board shall use money in the	64
fund for the expenses of the board and for purposes of the Ohio	65
aviation hall of fame and learning center. All investment	66
earnings of the fund shall be credited to the fund. The	67
treasurer of state shall disburse money from the fund on order	68
of the board.	69
