#### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4501.21 be amended and section	4
4503.951 of the Revised Code be enacted to read as follows:	5

treasury the license plate contribution fund. The fund shall	7
