

House Education and Career Readiness Committee House Bill 200 Testimony Robert A. Hancock, CPA Treasurer, Hamilton City School District November 14, 2017

Chairman Brenner, Vice Chair Slaby, Ranking Member Fedor and members of the committee. Thank you for the opportunity to address you concerning the provisions of HB 200. My name is Robert Hancock, Treasurer for the Hamilton City School District.

I am here on behalf of the Hamilton City School District Board of Education and the 9,634 students that attend our schools to express our opposition to HB 200. The Hamilton City School District is currently on the state funding cap by \$4.47 million. How is it that the state has funds available for private school vouchers when we need over \$506 million dollars to fund the formula that is currently in place?

The source data for the table below is the November #1 Foundation Funding Report and it details the dollar amounts needed by line item in the foundation report in order to fully fund the formula.

The table above illustrates Hamilton City School District state funds that have been sent to ECOT and Community Schools as a whole over the past 5 years. Think about the educational programs we could put in place to address the vast educational needs we experience as an urban school district.

The money that we are sending to Community Schools would go a long way toward implementing a full scale preschool program for 3 and 4 year old children. This would allow us to get our student population ready for kindergarten and would be the single largest thing we could do to enhance student achievement not only in Hamilton but across the State of Ohio.

We are doing a disservice to the students in our communities by diverting scare resources away from the public school system whether it be in the form of direct deduction from the school district's state funding or whether you implement a direct payment program to the parents of private school students. The end result is the public school system, where the vast majority of students are educated, is the one you choose to underfund.

It is time fully support the public school systems in Ohio, let's work together to provide high level educational programs to all students and we do that by ending the failed experiment of school vouchers.

Please note that we whole heartedly support a parent's right to seek a private education for their children but it is not our responsibility as taxpayers to fund that decision. I urge you to vote

against HB 200 and work hand in hand with your local boards of education to improve educational programs in our public schools which are charged with educating all students that live within their attendance boundaries.
