

## TESTIMONY IN SUPPORT OF HOUSE BILL 492

Chairwoman Anielski, Vice-Chair Hambley, Ranking Member Holmes and members of

the House State and Local Government Committee. My name is Elizabeth Radivoyevitch and I

am testifying today on behalf of the Cleveland Chapter of the National Association of Women

Business Owners (NAWBO) in support of HB 492, which would create a women's business

enterprise certification program in Ohio. I am the proud owner of a women's business

enterprise, RAD Graphics, Inc., and an active member of NAWBO Cleveland - as well as a past

President of our chapter.

Women business owners in Northeast Ohio that would like to compete for government

and certain private business in other states are at a disadvantage. Many times, they are rejected

for certifications that they would otherwise be eligible for if Ohio recognized women-owned

businesses. Some examples of these restrictions from other states are illustrated here:

<u>Kentucky:</u> Out-of-State Businesses ONLY: An out-of-state business must apply to the Kentucky MWBE program using the same business name under which it has been certified by a governmental certifying entity in the state where the principal place of business is located. The Business must possess current certification as a Disadvantaged Business Enterprise (DBE), Minority Business Enterprise (MBE) or Women Business Enterprise (WBE) from its home state, (i.e. the state where the principal place of business is located). https://mwbe.ky.gov/Pages/eligible.aspx

<u>Indiana:</u> Out-of-state firms must have equivalent certification from its state government agency. Proof of state certification must be provided with the certification application packet. City, county, commission and council certifications do not fulfill this requirement. http://www.in.gov/idoa/mwbe/2492.htm <u>Tennessee:</u> Out-of-State individuals seeking certification with Go-DBE must be certified in their home state of residence and submit evidence of their existing certification at the time of registration. <u>https://tn.diversitysoftware.com/upload/customer/tn/CertApp/Tennessee\_CertificationOverview.pdf</u>
