My name is Tim Duffey President of Shamrock Towing Inc., Shamrock was est. in 1952. we started doing private property towing in 1969 due to a ruling to give property owners protection from unauthorized parkers in their renters paid spaces. This came about because an OSU student was unable to park in her lot and parked a few blocks away. On her way home she was jumped and raped. At that point the property owners came together and created a law to protect the students and all property owners from illegal parkers. My 15-year employee handles the process of managing the letters and I have a statement from her I would like to read:

In regard to the required certified mailings, in the past 5-6 years that I've been doing them, it has shifted from one letter per vehicle to as many as 3 for the private property impounds. This in my opinion, does not increase the chances of the vehicles being picked up, it only increases the work load & cost. We not only have to pay to send the 2<sup>nd</sup> & 3<sup>rd</sup> letters, sometimes to both the owner and lien holders, which almost always never get picked up, we have to monitor it also, which is a full-time job in itself. Almost every letter sent for the private property impounds does not make it to the recipient, the 2<sup>nd</sup> letter must be sent within 30 days, so if it hasn't been physically returned to us, which it normally isn't within that 30 days, we have to rely on the post office's website to see if a 2<sup>nd</sup> letter is needed. Most of the time the reason it's being returned is different than what is on their website, so we're sending letters when it's not necessary, because the time constraint. The 3<sup>rd</sup> letter is even less time, so that is also another waste usually. 90% of the vehicles that are here long enough to get a letter, have long been abandoned by the owners. The recent influx of title loans has also upped the cost & labor as almost every junk vehicle has a lien on it & the new lien holders don't ever pick the vehicles up, as they're usually not worth the first day's cost.
