Seiberling's tireless commitment to the City of Akron and Summit County can be seen by the expansion of the city's economic growth, through awards like City Livability, the All-American City and label of High Tech Haven.

Stan Hywet Hall and Gardens was gifted for the benefit of the community in 1957 by the Seiberling's children. Since then Stan Hywet Hall and Garden's have been recognized as the 6th largest home in the United States, with five historic buildings and 10 historic gardens spanning 70 acres. It is also the 34th district and City of Akron's first and largest National Historic Landmark and is accredited by the American Alliance of Museums.
