My name is Auxiliary Lt. Colonel William J. Sanford, assistant commander of the Ohio State Highway Patrol Auxiliary. The Auxiliary is an all-volunteer force which provides assistance to Troopers in the course of their duties and to the Highway Patrol as a whole.

The Auxiliary was formed in 1942 when many commissioned Troopers entered the armed forces during World War II. Since then thousands of Auxiliaries have donated more than a million hours of service to both the Patrol and the citizens of Ohio. Last year alone our Auxiliary officers volunteered nearly 16,000 hours. Among the duties of an Auxiliary officer are crash scene and traffic stop assistance, traffic control, disaster relief and special detail support.

The Auxiliary also runs a foundation which is a 501(c)(3) public charity with a mission of supporting the Auxiliary, the Patrol and law enforcement in general. The Auxiliary Foundation wants to create an organizational license plate as described in House Bill 445 with the proceeds to benefit the Auxiliary Foundation and support our mission. This plate would have the Patrol's logo on it and the word "Supporter."
