Thank you for allowing me to provide proponent testimony on House Bill 474 which would create a TREES 4 OHIO license plate.

My name is Dixie Russell and I am the executive director of the Ohio Chapter International Society of Arboriculture, also referred to as ISA. The Chapter is established in Ohio as a 501(c)3 educational foundation whose mission is to advance responsible tree care practices through research, technology and education, while promoting the benefits of trees.

Trees provide many benefits to people and the communities they live in. Proper long-term care is essential to maximizing those benefits and ISA Certified Arborists, who are professional tree care providers, are individuals who have knowledge and training in the care needed to sustain a tree's life and maximize the long-term benefits.

More and more communities are beginning to recognize the tangible benefits that trees provide in the urban environment. Healthy trees reduce air and noise pollution, provide energy-saving shade and cooling, furnish habitat for wildlife, increase property values, and are an important contributor to a community's image, pride, and quality of life.
