BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 3333.0417 of the Revised Code be	6
enacted to read as follows:	7
Sec. 3333.0417. (A) As used in this section:	8
(1) "Public service organization" has the same meaning as_	9
in section 685.619 of Title 34 of the Code of Federal	10
Regulations, 34 C.F.R. 685.219.	11
(2) "Employment certification form" means the form used by	12
the United States department of education to certify an	13
individual's employment at a public service organization for the	14
purposes of the public service loan forgiveness program.	15

(3) "Public service loan forgiveness program" means the	16
loan forgiveness program established under 20 U.S.C. 1087e(m).	17
(4) "Teacher loan forgiveness program" means a loan	18
forgiveness program established under 20 U.S.C. 1078-10.	19
(B) The chancellor of higher education shall create and	20
distribute informational materials regarding the public service	21
loan forgiveness program and teacher loan forgiveness program to	22
public service organizations. Informational materials shall be	23
published on the department of higher education's web site and	24
updated each biennium. Materials shall include all of the	25
following:	26
(1) A letter to notify public employees of the eligibility	27
requirements of the public service and teacher loan forgiveness	28
programs and to recommend that public employees contact a	29
student loan servicer for additional information;	30
(2) A fact sheet that outlines the public service and	31
teacher loan forgiveness programs and contains contact	32
information for the chancellor;	33
(3) Frequently asked questions concerning the public_	34
