Please provide a brief statement on your position: I think that it is improper to employ retired judges when so many newly minted lawyers and other lawyers are available. I am also opposed to Mr. Cupp and what he supports. For example he supported the grab of my real estate in Penobscot County Maine, specifically the camp at Russell point about 6 miles west of Millinocket, Maine. You can witness this action by consulting the actions of the Ohio Supreme Court of 1 October, 2008. Mr. Cupp joined all the remaining judges all repubulicans in seizing my real estate and giving it to Elisabeth Ramsey, my mother's 'natural daughter' no genetic connection.. There is however there is a connection to a previous position of the Ohio Supreme Court in "A Life Well Lived" written by Paul E. Pfeifer on or about 24 May, 2000. I've had conversations with Michael Gmoser, the Butler Co. prosecutor about the theft.I had reason to contact the Superior Court of Spokane County and their lawyer noted the same horror. Nothing proposed by Robert Cupp should be move forward. Mom was an U.S. Army veteran who sailed in a darkened trans Atlantic convoy from NYC to Glasgow in April ,1944. We cannot maintain Catherine's grave because of this f
