The state was also critical of Oklahoma-based Gulfport Energy Corp. that had contracted with Harch Environmental to dispose of the wastes.

The fact that the wastes were illegally dumped indicates that Gulfport Energy failed to meet its responsibility to monitor oil field waste from inception to injection, the state said.

The state agency is consulting with the Ohio Attorney General's office regarding any civil or criminal penalties both against Harch Environmental and Gulfport Energy.

Brine water dumped into Barnesville reservoir

BARNESVILLE - Gulfport Energy contractors may not be drawing any water from the village reservoir, but an Ohio Environmental Protection Agency spokesman said the company is responsible for 5,000 gallons of brine that leaked into a stream leading to the reservoir Wednesday.

Officials with Ohio EPA and the state's Department of Natural Resources joined local emergency authorities to investigate the scene along Ohio 800 south of Barnesville on Wednesday after a tractor-trailer overturned around 3 a.m. Barnesville Fire Chief Bob Smith said emergency workers flew the truck driver to a Columbus area hospital for unspecified injuries via medical helicopter. No other vehicles were involved in the crash, he said.

NOTE: At the scene the Ohio EPA explained to one of the fire chiefs who responded, that the brine had no chemicals in it. This would be extremely improbable, as hydrofracking uses many

chemicals during 100% of frack jobs. This truck was delivering radioactive toxic brine liquid waste from a frack pad to an injection well.
