Dear Chair,

Thank you Chair, Ranking Member, and members of the committee for the opportunity to testify in opposition to House Bill 798. My name is Tristan Rader, and I am the Director at Solar United Neighbors of Ohio. We are a non-profit organization that represents thousands of solar homeowners. Solar United Neighbors helps people go solar and fight for their energy rights.

We strongly opposed HB 6 because the bill unfairly forces Ohio ratepayers and taxpayers to subsidize failing coal and nuclear electricity-generating operations, and because it weakens the state's sensible clean energy policies and delays the necessary and beneficial movement to building a cleaner energy economy for all Ohioans. On policy grounds and in light of the outrageous corruption scandal surrounding the bill's passage, we support a full and clean repeal immediately. HB 798 is clearly not that. Rather, this bill attempts to affirm HB 6.

Passing HB 798 would send a clear message that bribery works in Ohio. It would show that both our democracy and criminal justice system are inadequate to stop the illegal influence of money in politics. If passed, HB 798 would ensure that FirstEnergy receives \$130 million a year in perpetuity. This is the same FirstEnergy (now called EnergyHarbor) that organized and funded the \$61 million bribery scheme to secure this bailout.

This bill is not the repeal that legislators, on both sides of the aisle, and Governor DeWine, have called for. Please, do what is right: Fully and immediately repeal HB 6.
