Chairman Wiggam, Vice Chairman Stephens, Ranking Member Kelly, and members of the State and Local Government Committee: Thank you for allowing me sponsor testimony for HB 618.

My name is Damon Appel, and I was Born in Ohio in 1968. In my 52 years living here I never dreamed to see a day in America, let alone Ohio, wherein a Governor and his Executive associates would wield absolute power over the populace. Even more disheartening is that this practice of issuing orders of fiat would continue not just for weeks, but months without an end in sight, and based upon the most imaginative use of an arcane old section of the Ohio Revised Code.

It's because people ARE dying. They're dying inside.

Confused and oppressed, they are forgetting the very things this Nation was built to stand for. Depressed and forlorn, some even take their lives; bereft of hope, having lost their lives' work, broken their families...all at the hands of this Governor and his despotic Administration.

I am fortunate, and I am blessed. Oh, I did lose a significant relationship in this mess. We weren't getting along well as it was; but the 'lockdown' certainly didn't help.

But I am fortunate to be one of those employed in a so-called "essential" industry where working at home is little different from working in-person.

I'll wear a mask when I desire to visit the store or the restaurant, so as not to cause a fuss. But I don't have to wear it all day, like they do.

--A symbol of compliance that the verdict of 'science' is clearly not settled upon, as to its actual physical effectiveness.

Governor DeWine threatens to close these struggling restaurants, bars and other miscellaneous businesses as he sees fit, yet again.
