Dear Chairman Wilson and Members of the Ohio Senate Energy and Public Utilities Committee,

Please allow the citizens with the least to gain and the most to lose an opportunity to express their opinion on the matter of wind projects in their communities.

Seneca and surrounding counties have become the latest victims in Ohio of a flawed process for siting wind projects. The current process favors big wind corporations and those who would financially benefit. The citizens are otherwise left to live with the projects in their communities.

A home is a major investment for many individuals and to help protect these investments communities have established local zoning regulations and elected officials (Township Trustees and County Commissioners) to enforce these regulations. Ohio law does not allow our local zoning regulations to be considered when it comes to wind projects. What is the purpose of local zoning if it is going to be ignored by state agencies?

At the time of this letter, not only are a majority of the local citizens against the projects but all five of the townships affected by Republic Wind have passed resolutions in opposition, the Seneca County Commissioners have passed resolutions in opposition, the county has officially ended the alternative energy zone, and multiple county agencies and a school have expressed opposition to the project. Despite the people expressing their opinion on the matter through all these methods, why does the process still favor the wind companies and ignore the opinion of the people of Ohio?

The wind companies claim that wind energy and wind projects are "good for the area" and "wanted by residents" yet nearly all of the support for the project is from those who financially are benefiting or do not even live, work, raise children, or contribute to the area. If the claims of support are true, why do the wind companies and their lobbying organizations object to the local community voting on the matter?
