My name is Dee Dee Giese, and I am the Ohio Sierra Club Political Committee Chair.

Today, I am stating my personal point of view.

Thank you for the opportunity to comment upon HB6 today. As noted by others, what a DISGRACE it is that the Legislature has not invited the public to testify on the repeal of HB6.

HB6 is a BAD BILL. It is a BAD BILL because it is tainted by corruption, bribery, racketeering, and scandal to do a BAD THING – prop up the dirty fuel industries of nuclear and coal.
