I want to express my deepest gratitude to Governor DeWine, Director Davis, the Ohio Department of Developmental Disabilities, and the Ohio House of Representatives who, separately and collectively, have made an unprecedented investment in services for individuals with intellectual and developmental disabilities. I am appreciative of the administration and the Ohio House's proposal to invest in the homemaker/personal care service to help increase the average wage of DSPs providing that service. RHDD is a small enough agency that I personally know many of our DSP staff, and see the struggle they face to support their families on DSP wages.
