Sponsor Testimony

Senate Bill 331

Ohio Senate General Government and Agency Review Committee
November 18, 2020

Chair Schuring, Vice-chair Rulli, Ranking Member O'Brien and members of the General Government and Agency Review Committee, thank you for the opportunity to provide sponsor testimony on Senate Bill 331, which adopts the recommendations of the Sunset Review Committee.

As you know, the Sunset Review Committee is responsible for reviewing the structure and activity of Ohio's boards and commissions every other biennium. The bill before you today is the recommendation of the committee, and was approved by all of its members.

There are three components of the bill you have before you. The first component is the reauthorization of all active boards and commissions. Reauthorization is necessary for these boards and commissions to continue their work in future General Assemblies. If the legislature does not act to reauthorize these entities, they will automatically expire under the Sunset Review Law (as established by Sub. H.B. 548 of the 123rd General Assembly). The bill before you today reauthorizes the vast majority of these entities.

The second component of this legislation is the sunset of entities that are no longer necessary or that have completed their work. Based on the testimony

received during the committee process, the Sunset Review Committee unanimously agreed that these below boards and commissions should be sunset:

Additionally, as the bill before you was introduced prior to the committee's last meeting, I will also be submitting an amendment to the committee to sunset four additional boards that were not included in the as-introduced version of the bill, but are also no longer necessary. These additional four unnecessary boards include:

The third component of this bill involves improving the efficiency of government in Ohio. The primary way the bill works toward this end is a restructuring of the Sunset Committee process. You will see that some of the boards and commissions in the bill were reauthorized for a two year term, while others were renewed for four years.

The rationale for this bifurcation is that the committee discussed the possibility of making the Sunset Review Committee process take place each biennium instead of every other biennium, in hopes of giving the committee more time to review each board. The bill before you today envisions the Sunset Review Committee reviewing half of the boards and commissions each biennium, instead of the entire number every other biennium. I am very open to reconsidering this decision and restoring the existing process, but felt that this proposal deserved consideration by the legislature.

The bill also allows the Ohio Judicial Conference to distribute their Judicial Impact Statements electronically, rather than by physical copy. The committee felt that this request was a common-sense proposal, one that gains even more justification in the COVID-19 era.

I'd like to thank the members of the Sunset Review Committee, including Senators McColley and Thomas, Representatives Wiggam and Kelly, Director Thrasher, Mr. Yassenoff, and Mr. Perera, with a special thanks to Vice-chair Vitale for his work in leading the review process for the first year of the 133rd General Assembly.
