On behalf of the 2,900 members of the Ohio Chapter of the American Academy of Pediatrics, I am writing today to express our support for House Bill 412, sponsored by State Representatives Clites and Ginter.

As you know, this legislation would establish the Rare Disease Advisory Council under the Ohio Department of Health (ODH). This group of advocates and experts would provide recommendations to the General Assembly regarding the needs of patients with a rare disease.
