As the mayor of Toledo in Lucas County, we have worked closely with the Lucas County Land Bank over the past 10 years to preserve property values, strengthen our neighborhoods, and support economic development goals.

During the past decade, our Land Bank has helped to return nearly 5,000 previously abandoned properties to productive use and leveraged more than \$50 million of public and private investment to strengthen neighborhoods. By using the legislative tools made available to land banks through the Ohio General Assembly's actions, we have made significant strides toward the betterment of Toledo and Lucas County.

There are many examples – both large and small – where Toledoans have celebrated the work of the Land Bank. May 13, 2020 was a historic day for 2347 Glenwood Ave. in the Old West End neighborhood of our community. That two-story, 122-year-old home was vacant and neglected several years ago, but through the Land Bank's efforts, it was renovated and listed for sale. The home marked a milestone for us, as we celebrated the completion of the Land Bank's plan to renovate or demolish 1,500 area properties, including that residence.

The Land Bank has been instrumental in the redevelopment efforts of large, local landmark properties, including the Pythian Castle, the former St. Anthony's church building, the historic Spitzer building and its neighboring Fifth Third Center and Port Lawrence buildings that sit on or near the corner of Madison Avenue and Huron Street in Downtown Toledo.
