BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO (THE SENATE CONCURRING):

WHEREAS, COVID-19 is a respiratory disease caused by the	4
SARS-CoV-2 virus that can easily spread from person to person	5
and may result in serious illness or death; and	6
WHEREAS, The World Health Organization (WHO) defines stigma	7
as the labeling, stereotyping, separation, loss of status, and	8
discrimination due to a person's negative affiliation with a	9
disease; and	10
WHEREAS, A collaborative stigma guide created by the WHO,	11
UNICEF, and the International Federation of Red Cross and Red	12
Crescent Societies (IFRC) states that COVID-19 is associated	13
with a high level of stigma because (1) it is a new disease	14
surrounded by uncertainty, (2) people are often afraid of the	15
unknown, and (3) it is easy to project fear onto minority	16
groups; and	17
WHEREAS, The Centers for Disease Control and Prevention	18

(CDC) reports that people of Asian descent are especially	19
vulnerable to stigmatization due to COVID-19, while emphasizing	20
that virus transmission is not connected to race or ethnicity;	21

WHEREAS, Other groups of people such as health care workers	23
or people who have traveled recently also may experience stigma;	24
and	25
WHEREAS, According to the CDC, stigma can result in social	26
avoidance or rejection; denial of health care, education,	27
housing, or employment; and physical violence; and	28
WHEREAS, According to the WHO, UNICEF, and the IFRC, stigma	29
can drive people to hide illness, prevent people from seeking	30
health care immediately, and discourage people from adopting	31
healthy behaviors; and	32
WHEREAS, These consequences of stigma can ultimately	33
exacerbate the spread of COVID-19; and	34
WHEREAS, The CDC, WHO, UNICEF, and IFRC all affirm that the	35
most effective way to combat stigma is for people to speak out	36
against it, especially people in positions of power and	37
influence; now therefore be it	38
RESOLVED, That we, the members of the 133rd General	39

out and advocate on behalf of people who are experiencing stigma	41
