### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

<b>Section 1.</b> That section 4743.11 of the Revised Code be	7

or patient representative's consent, is present during a medical	11
examination.	
(2) "Health care professional" means all of the following:	13

(b) A physician assistant licensed under Chapter 4730. of	16

(c) A physician authorized to practice medicine and	18
surgery, osteopathic medicine and surgery, or podiatric medicine	19
and surgery under Chapter 4731. of the Revised Code;	20
(d) An individual authorized to practice a limited branch	21
(d) An individual authorized to practice a limited branch	
of medicine under Chapter 4731. of the Revised Code;	22
(e) An anesthesiologist assistant licensed under Chapter	23

(f) An acupuncturist licensed under Chapter 4762. of the	25

(3) "Intimate examination" means a medical examination of	31
the pelvic area, genitals, rectum, breast, or prostate.	32
(4) "State licensing board" means the board of nursing or	33
state medical board.	34
(B) Before conducting an intimate examination of a	35
patient, a health care professional described in division (A)(2)	36
(a), (b), or (c) of this section shall offer the patient or	37
patient's representative a medical chaperone.	38
The health care professional may refuse to conduct the	39
