A BILL

To amend sections 3301.0711, 3301.163, and 3313.608
of the Revised Code to eliminate retention under
the Third Grade Reading Guarantee.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 3301.0711, 3301.163, and 3313.608
of the Revised Code be amended to read as follows:

Sec. 3301.0711. (A) The department of education shall:

(1) Annually furnish to, grade, and score all assessments
required by divisions (A) (1) and (B) (1) of section 3301.0710 of
the Revised Code to be administered by city, local, exempted
village, and joint vocational school districts, except that each
district shall score any assessment administered pursuant to
division (B) (10) of this section. Each assessment so furnished
shall include the data verification code of the student to whom
the assessment will be administered, as assigned pursuant to
division (D) (2) of section 3301.0714 of the Revised Code. In

furnishing the practice versions of Ohio graduation tests 16
prescribed by division (D) of section 3301.0710 of the Revised 17
Code, the department shall make the tests available on its web 18
site for reproduction by districts. In awarding contracts for 19
grading assessments, the department shall give preference to 20
Ohio-based entities employing Ohio residents. 21

(2) Adopt rules for the ethical use of assessments and 22
prescribing the manner in which the assessments prescribed by 23
section 3301.0710 of the Revised Code shall be administered to 24
students. 25

(B) Except as provided in divisions (C) and (J) of this 26
section, the board of education of each city, local, and 27
exempted village school district shall, in accordance with rules 28
adopted under division (A) of this section: 29

(1) ~~Administer~~ Until the 2020-2021 school year, administer 30
the English language arts assessments prescribed under division 31
(A) (1) (a) of section 3301.0710 of the Revised Code twice 32
annually to all students in the third grade who have not 33
attained the score designated for that assessment under division 34
(A) (2) (c) of section 3301.0710 of the Revised Code. Beginning 35
with the 2021-2022 school year, the English language arts 36
assessment shall be administered only once to all students in 37
the third grade. 38

(2) Administer the mathematics assessment prescribed under 39
division (A) (1) (a) of section 3301.0710 of the Revised Code at 40
least once annually to all students in the third grade. 41

(3) Administer the assessments prescribed under division 42
(A) (1) (b) of section 3301.0710 of the Revised Code at least once 43
annually to all students in the fourth grade. 44

(4) Administer the assessments prescribed under division 45
(A) (1) (c) of section 3301.0710 of the Revised Code at least once 46
annually to all students in the fifth grade. 47

(5) Administer the assessments prescribed under division 48
(A) (1) (d) of section 3301.0710 of the Revised Code at least once 49
annually to all students in the sixth grade. 50

(6) Administer the assessments prescribed under division 51
(A) (1) (e) of section 3301.0710 of the Revised Code at least once 52
annually to all students in the seventh grade. 53

(7) Administer the assessments prescribed under division 54
(A) (1) (f) of section 3301.0710 of the Revised Code at least once 55
annually to all students in the eighth grade. 56

(8) Except as provided in division (B) (9) of this section, 57
administer any assessment prescribed under division (B) (1) of 58
section 3301.0710 of the Revised Code as follows: 59

(a) At least once annually to all tenth grade students and 60
at least twice annually to all students in eleventh or twelfth 61
grade who have not yet attained the score on that assessment 62
designated under that division; 63

(b) To any person who has successfully completed the 64
curriculum in any high school or the individualized education 65
program developed for the person by any high school pursuant to 66
section 3323.08 of the Revised Code but has not received a high 67
school diploma and who requests to take such assessment, at any 68
time such assessment is administered in the district. 69

(9) In lieu of the board of education of any city, local, 70
or exempted village school district in which the student is also 71
enrolled, the board of a joint vocational school district shall 72
administer any assessment prescribed under division (B) (1) of 73

section 3301.0710 of the Revised Code at least twice annually to 74
any student enrolled in the joint vocational school district who 75
has not yet attained the score on that assessment designated 76
under that division. A board of a joint vocational school 77
district may also administer such an assessment to any student 78
described in division (B) (8) (b) of this section. 79

(10) If the district has a three-year average graduation 80
rate of not more than seventy-five per cent, administer each 81
assessment prescribed by division (D) of section 3301.0710 of 82
the Revised Code in September to all ninth grade students who 83
entered ninth grade prior to July 1, 2014. 84

Except as provided in section 3313.614 of the Revised Code 85
for administration of an assessment to a person who has 86
fulfilled the curriculum requirement for a high school diploma 87
but has not passed one or more of the required assessments, the 88
assessments prescribed under division (B) (1) of section 89
3301.0710 of the Revised Code shall not be administered after 90
the date specified in the rules adopted by the state board of 91
education under division (D) (1) of section 3301.0712 of the 92
Revised Code. 93

(11) (a) Except as provided in divisions (B) (11) (b) and (c) 94
of this section, administer the assessments prescribed by 95
division (B) (2) of section 3301.0710 and section 3301.0712 of 96
the Revised Code in accordance with the timeline and plan for 97
implementation of those assessments prescribed by rule of the 98
state board adopted under division (D) (1) of section 3301.0712 99
of the Revised Code; 100

(b) A student who has presented evidence to the district 101
or school of having satisfied the condition prescribed by 102
division (A) (1) of section 3313.618 of the Revised Code to 103

qualify for a high school diploma prior to the date of the 104
administration of the assessment prescribed under division (B) 105
(1) of section 3301.0712 of the Revised Code shall not be 106
required to take that assessment. However, no board shall 107
prohibit a student who is not required to take such assessment 108
from taking the assessment. 109

(c) A student shall not be required to retake the Algebra 110
I end-of-course examination or the English language arts II end- 111
of-course examination prescribed under division (B) (2) of 112
section 3301.0712 of the Revised Code in grades nine through 113
twelve if the student demonstrates at least a proficient level 114
of skill, as prescribed under division (B) (5) (a) of that 115
section, or achieves a competency score, as prescribed under 116
division (B) (10) of that section, in an administration of the 117
examination prior to grade nine. 118

(C) (1) (a) In the case of a student receiving special 119
education services under Chapter 3323. of the Revised Code, the 120
individualized education program developed for the student under 121
that chapter shall specify the manner in which the student will 122
participate in the assessments administered under this section, 123
except that a student with significant cognitive disabilities to 124
whom an alternate assessment is administered in accordance with 125
division (C) (1) of this section and a student determined to have 126
a disability that includes an intellectual disability as 127
outlined in guidance issued by the department shall not be 128
required to take the assessment prescribed under division (B) (1) 129
of section 3301.0712 of the Revised Code. The individualized 130
education program may excuse the student from taking any 131
particular assessment required to be administered under this 132
section if it instead specifies an alternate assessment method 133
approved by the department of education as conforming to 134

requirements of federal law for receipt of federal funds for 135
disadvantaged pupils. To the extent possible, the individualized 136
education program shall not excuse the student from taking an 137
assessment unless no reasonable accommodation can be made to 138
enable the student to take the assessment. No board shall 139
prohibit a student who is not required to take an assessment 140
under division (C) (1) of this section from taking the 141
assessment. 142

(b) Any alternate assessment approved by the department 143
for a student under this division shall produce measurable 144
results comparable to those produced by the assessment it 145
replaces in order to allow for the student's results to be 146
included in the data compiled for a school district or building 147
under section 3302.03 of the Revised Code. 148

(c) (i) Any student enrolled in a chartered nonpublic 149
school who has been identified, based on an evaluation conducted 150
in accordance with section 3323.03 of the Revised Code or 151
section 504 of the "Rehabilitation Act of 1973," 87 Stat. 355, 152
29 U.S.C.A. 794, as amended, as a child with a disability shall 153
be excused from taking any particular assessment required to be 154
administered under this section if either of the following 155
apply: 156

(I) A plan developed for the student pursuant to rules 157
adopted by the state board excuses the student from taking that 158
assessment. 159

(II) The chartered nonpublic school develops a written 160
plan in which the school, in consultation with the student's 161
parents, determines that an assessment or alternative assessment 162
with accommodations does not accurately assess the student's 163
academic performance. The plan shall include an academic profile 164

of the student's academic performance and shall be reviewed 165
annually to determine if the student's needs continue to require 166
excusal from taking the assessment. 167

(ii) A student with significant cognitive disabilities to 168
whom an alternate assessment is administered in accordance with 169
division (C) (1) of this section and a student determined to have 170
a disability that includes an intellectual disability as 171
outlined in guidance issued by the department shall not be 172
required to take the assessment prescribed under division (B) (1) 173
of section 3301.0712 of the Revised Code. 174

(iii) In the case of any student so excused from taking an 175
assessment under division (C) (1) (c) of this section, the 176
chartered nonpublic school shall not prohibit the student from 177
taking the assessment. 178

(2) A district board may, for medical reasons or other 179
good cause, excuse a student from taking an assessment 180
administered under this section on the date scheduled, but that 181
assessment shall be administered to the excused student not 182
later than nine days following the scheduled date. The district 183
board shall annually report the number of students who have not 184
taken one or more of the assessments required by this section to 185
the state board not later than the thirtieth day of June. 186

(3) As used in this division, "English learner" has the 187
same meaning as in 20 U.S.C. 7801. 188

No school district board shall excuse any English learner 189
from taking any particular assessment required to be 190
administered under this section, except as follows: 191

(a) Any English learner who has been enrolled in United 192
States schools for less than two years and for whom no 193

appropriate accommodations are available based on guidance 194
issued by the department shall not be required to take the 195
assessment prescribed under division (B) (1) of section 3301.0712 196
of the Revised Code. 197

(b) Any English learner who has been enrolled in United 198
States schools for less than one full school year shall not be 199
required to take any reading, writing, or English language arts 200
assessment. 201

However, no board shall prohibit an English learner who is 202
not required to take an assessment under division (C) (3) of this 203
section from taking the assessment. A board may permit any 204
English learner to take an assessment required to be 205
administered under this section with appropriate accommodations, 206
as determined by the department. For each English learner, each 207
school district shall annually assess that student's progress in 208
learning English, in accordance with procedures approved by the 209
department. 210

(4) (a) The governing authority of a chartered nonpublic 211
school may excuse an English learner from taking any assessment 212
administered under this section. 213

(b) No governing authority shall require an English 214
learner who has been enrolled in United States schools for less 215
than two years and for whom no appropriate accommodations are 216
available based on guidance issued by the department to take the 217
assessment prescribed under division (B) (1) of section 3301.0712 218
of the Revised Code. 219

(c) No governing authority shall prohibit an English 220
learner from taking an assessment from which the student was 221
excused under division (C) (4) of this section. 222

(D) (1) In the school year next succeeding the school year 223
in which the assessments prescribed by division (A) (1) or (B) (1) 224
of section 3301.0710 of the Revised Code or former division (A) 225
(1), (A) (2), or (B) of section 3301.0710 of the Revised Code as 226
it existed prior to September 11, 2001, are administered to any 227
student, the board of education of any school district in which 228
the student is enrolled in that year shall provide to the 229
student intervention services commensurate with the student's 230
performance, including any intensive intervention required under 231
section 3313.608 of the Revised Code, in any skill in which the 232
student failed to demonstrate at least a score at the proficient 233
level on the assessment. 234

(2) Following any administration of the assessments 235
prescribed by division (D) of section 3301.0710 of the Revised 236
Code to ninth grade students, each school district that has a 237
three-year average graduation rate of not more than seventy-five 238
per cent shall determine for each high school in the district 239
whether the school shall be required to provide intervention 240
services to any students who took the assessments. In 241
determining which high schools shall provide intervention 242
services based on the resources available, the district shall 243
consider each school's graduation rate and scores on the 244
practice assessments. The district also shall consider the 245
scores received by ninth grade students on the English language 246
arts and mathematics assessments prescribed under division (A) 247
(1) (f) of section 3301.0710 of the Revised Code in the eighth 248
grade in determining which high schools shall provide 249
intervention services. 250

Each high school selected to provide intervention services 251
under this division shall provide intervention services to any 252
student whose results indicate that the student is failing to 253

make satisfactory progress toward being able to attain scores at 254
the proficient level on the Ohio graduation tests. Intervention 255
services shall be provided in any skill in which a student 256
demonstrates unsatisfactory progress and shall be commensurate 257
with the student's performance. Schools shall provide the 258
intervention services prior to the end of the school year, 259
during the summer following the ninth grade, in the next 260
succeeding school year, or at any combination of those times. 261

(E) Except as provided in section 3313.608 of the Revised 262
Code and division (N) of this section, no school district board 263
of education shall utilize any student's failure to attain a 264
specified score on an assessment administered under this section 265
as a factor in any decision to deny the student promotion to a 266
higher grade level. However, a district board may choose not to 267
promote to the next grade level any student who does not take an 268
assessment administered under this section or make up an 269
assessment as provided by division (C) (2) of this section and 270
who is not exempt from the requirement to take the assessment 271
under division (C) (3) of this section. 272

(F) No person shall be charged a fee for taking any 273
assessment administered under this section. 274

(G) (1) Each school district board shall designate one 275
location for the collection of assessments administered in the 276
spring under division (B) (1) of this section and those 277
administered under divisions (B) (2) to (7) of this section. Each 278
district board shall submit the assessments to the entity with 279
which the department contracts for the scoring of the 280
assessments as follows: 281

(a) If the district's total enrollment in grades 282
kindergarten through twelve during the first full school week of 283

October was less than two thousand five hundred, not later than 284
the Friday after all of the assessments have been administered; 285

(b) If the district's total enrollment in grades 286
kindergarten through twelve during the first full school week of 287
October was two thousand five hundred or more, but less than 288
seven thousand, not later than the Monday after all of the 289
assessments have been administered; 290

(c) If the district's total enrollment in grades 291
kindergarten through twelve during the first full school week of 292
October was seven thousand or more, not later than the Tuesday 293
after all of the assessments have been administered. 294

However, any assessment that a student takes during the 295
make-up period described in division (C) (2) of this section 296
shall be submitted not later than the Friday following the day 297
the student takes the assessment. 298

(2) The department or an entity with which the department 299
contracts for the scoring of the assessment shall send to each 300
school district board a list of the individual scores of all 301
persons taking a state achievement assessment as follows: 302

(a) Except as provided in division (G) (2) (b) or (c) of 303
this section, within forty-five days after the administration of 304
the assessments prescribed by sections 3301.0710 and 3301.0712 305
of the Revised Code, but in no case shall the scores be returned 306
later than the thirtieth day of June following the 307
administration; 308

(b) In the case of the third-grade English language arts 309
assessment, within forty-five days after the administration of 310
that assessment, but in no case shall the scores be returned 311
later than the fifteenth day of June following the 312

administration; 313

(c) In the case of the writing component of an assessment 314
or end-of-course examination in the area of English language 315
arts, except for the third-grade English language arts 316
assessment, the results may be sent after forty-five days of the 317
administration of the writing component, but in no case shall 318
the scores be returned later than the thirtieth day of June 319
following the administration. 320

(3) For assessments administered under this section by a 321
joint vocational school district, the department or entity shall 322
also send to each city, local, or exempted village school 323
district a list of the individual scores of any students of such 324
city, local, or exempted village school district who are 325
attending school in the joint vocational school district. 326

(4) Beginning with the 2019-2020 school year, a school 327
district, other public school, or chartered nonpublic school may 328
administer the third-grade English language arts or mathematics 329
assessment, or both, in a paper format in any school year for 330
which the district board of education or school governing body 331
adopts a resolution indicating that the district or school 332
chooses to administer the assessment in a paper format. The 333
board or governing body shall submit a copy of the resolution to 334
the department of education not later than the first day of May 335
prior to the school year for which it will apply. If the 336
resolution is submitted, the district or school shall administer 337
the assessment in a paper format to all students in the third 338
grade, except that any student whose individualized education 339
program or plan developed under section 504 of the 340
"Rehabilitation Act of 1973," 87 Stat. 355, 29 U.S.C. 794, as 341
amended, specifies that taking the assessment in an online 342

format is an appropriate accommodation for the student may take 343
the assessment in an online format. 344

(H) Individual scores on any assessments administered 345
under this section shall be released by a district board only in 346
accordance with section 3319.321 of the Revised Code and the 347
rules adopted under division (A) of this section. No district 348
board or its employees shall utilize individual or aggregate 349
results in any manner that conflicts with rules for the ethical 350
use of assessments adopted pursuant to division (A) of this 351
section. 352

(I) Except as provided in division (G) of this section, 353
the department or an entity with which the department contracts 354
for the scoring of the assessment shall not release any 355
individual scores on any assessment administered under this 356
section. The state board shall adopt rules to ensure the 357
protection of student confidentiality at all times. The rules 358
may require the use of the data verification codes assigned to 359
students pursuant to division (D) (2) of section 3301.0714 of the 360
Revised Code to protect the confidentiality of student scores. 361

(J) Notwithstanding division (D) of section 3311.52 of the 362
Revised Code, this section does not apply to the board of 363
education of any cooperative education school district except as 364
provided under rules adopted pursuant to this division. 365

(1) In accordance with rules that the state board shall 366
adopt, the board of education of any city, exempted village, or 367
local school district with territory in a cooperative education 368
school district established pursuant to divisions (A) to (C) of 369
section 3311.52 of the Revised Code may enter into an agreement 370
with the board of education of the cooperative education school 371
district for administering any assessment prescribed under this 372

section to students of the city, exempted village, or local 373
school district who are attending school in the cooperative 374
education school district. 375

(2) In accordance with rules that the state board shall 376
adopt, the board of education of any city, exempted village, or 377
local school district with territory in a cooperative education 378
school district established pursuant to section 3311.521 of the 379
Revised Code shall enter into an agreement with the cooperative 380
district that provides for the administration of any assessment 381
prescribed under this section to both of the following: 382

(a) Students who are attending school in the cooperative 383
district and who, if the cooperative district were not 384
established, would be entitled to attend school in the city, 385
local, or exempted village school district pursuant to section 386
3313.64 or 3313.65 of the Revised Code; 387

(b) Persons described in division (B) (8) (b) of this 388
section. 389

Any assessment of students pursuant to such an agreement 390
shall be in lieu of any assessment of such students or persons 391
pursuant to this section. 392

(K) (1) (a) Except as otherwise provided in division (K) (1) 393
or (2) of this section, each chartered nonpublic school for 394
which at least sixty-five per cent of its total enrollment is 395
made up of students who are participating in state scholarship 396
programs shall administer the assessments prescribed by division 397
(A) of section 3301.0710 of the Revised Code or an alternative 398
standardized assessment determined by the department. In 399
accordance with procedures and deadlines prescribed by the 400
department, the parent or guardian of a student enrolled in the 401

school who is not participating in a state scholarship program 402
may submit notice to the chief administrative officer of the 403
school that the parent or guardian does not wish to have the 404
student take the assessments prescribed for the student's grade 405
level under division (A) of section 3301.0710 of the Revised 406
Code. If a parent or guardian submits an opt-out notice, the 407
school shall not administer the assessments to that student. 408
This option does not apply to any assessment required for a high 409
school diploma under section 3313.612 of the Revised Code. 410

(b) Any chartered nonpublic school that enrolls students 411
who are participating in state scholarship programs may 412
administer an alternative standardized assessment determined by 413
the department instead of the assessments prescribed by division 414
(A) of section 3301.0710 of the Revised Code. 415

Each chartered nonpublic school subject to division (K) (1) 416
(a) or (b) of this section shall report the results of each 417
assessment administered under those divisions to the department. 418

(2) A chartered nonpublic school may submit to the 419
superintendent of public instruction a request for a waiver from 420
administering the elementary assessments prescribed by division 421
(A) of section 3301.0710 of the Revised Code. The state 422
superintendent shall approve or disapprove a request for a 423
waiver submitted under division (K) (2) of this section. No 424
waiver shall be approved for any school year prior to the 2015- 425
2016 school year. 426

To be eligible to submit a request for a waiver, a 427
chartered nonpublic school shall meet the following conditions: 428

(a) At least ninety-five per cent of the students enrolled 429
in the school are children with disabilities, as defined under 430

section 3323.01 of the Revised Code, or have received a 431
diagnosis by a school district or from a physician, including a 432
neuropsychiatrist or psychiatrist, or a psychologist who is 433
authorized to practice in this or another state as having a 434
condition that impairs academic performance, such as dyslexia, 435
dyscalculia, attention deficit hyperactivity disorder, or 436
Asperger's syndrome. 437

(b) The school has solely served a student population 438
described in division (K)(1)(a) of this section for at least ten 439
years. 440

(c) The school provides to the department at least five 441
years of records of internal testing conducted by the school 442
that affords the department data required for accountability 443
purposes, including diagnostic assessments and nationally 444
standardized norm-referenced achievement assessments that 445
measure reading and math skills. 446

(3) Any chartered nonpublic school that is not subject to 447
division (K)(1) of this section may participate in the 448
assessment program by administering any of the assessments 449
prescribed by division (A) of section 3301.0710 of the Revised 450
Code. The chief administrator of the school shall specify which 451
assessments the school will administer. Such specification shall 452
be made in writing to the superintendent of public instruction 453
prior to the first day of August of any school year in which 454
assessments are administered and shall include a pledge that the 455
nonpublic school will administer the specified assessments in 456
the same manner as public schools are required to do under this 457
section and rules adopted by the department. 458

(4) The department of education shall furnish the 459
assessments prescribed by section 3301.0710 of the Revised Code 460

to each chartered nonpublic school that is subject to division 461
(K) (1) of this section or participates under division (K) (3) of 462
this section. 463

(L) If a chartered nonpublic school is educating students 464
in grades nine through twelve, the following shall apply: 465

(1) Except as provided in division (L) (4) of this section, 466
for a student who is enrolled in a chartered nonpublic school 467
that is accredited through the independent schools association 468
of the central states and who is attending the school under a 469
state scholarship program, the student shall either take all of 470
the assessments prescribed by division (B) of section 3301.0712 471
of the Revised Code or take an alternative assessment approved 472
by the department under section 3313.619 of the Revised Code. 473
However, a student who is excused from taking an assessment 474
under division (C) of this section or has presented evidence to 475
the chartered nonpublic school of having satisfied the condition 476
prescribed by division (A) (1) of section 3313.618 of the Revised 477
Code to qualify for a high school diploma prior to the date of 478
the administration of the assessment prescribed under division 479
(B) (1) of section 3301.0712 of the Revised Code shall not be 480
required to take that assessment. No governing authority of a 481
chartered nonpublic school shall prohibit a student who is not 482
required to take such assessment from taking the assessment. 483

(2) For a student who is enrolled in a chartered nonpublic 484
school that is accredited through the independent schools 485
association of the central states, and who is not attending the 486
school under a state scholarship program, the student shall not 487
be required to take any assessment prescribed under section 488
3301.0712 or 3313.619 of the Revised Code. 489

(3) (a) Except as provided in divisions (L) (3) (b) and (4) 490

of this section, for a student who is enrolled in a chartered 491
nonpublic school that is not accredited through the independent 492
schools association of the central states, regardless of whether 493
the student is attending or is not attending the school under a 494
state scholarship program, the student shall do one of the 495
following: 496

(i) Take all of the assessments prescribed by division (B) 497
of section 3301.0712 of the Revised Code; 498

(ii) Take only the assessment prescribed by division (B) 499
(1) of section 3301.0712 of the Revised Code, provided that the 500
student's school publishes the results of that assessment for 501
each graduating class. The published results of that assessment 502
shall include the overall composite scores, mean scores, twenty- 503
fifth percentile scores, and seventy-fifth percentile scores for 504
each subject area of the assessment. 505

(iii) Take an alternative assessment approved by the 506
department under section 3313.619 of the Revised Code. 507

(b) A student who is excused from taking an assessment 508
under division (C) of this section or has presented evidence to 509
the chartered nonpublic school of having satisfied the condition 510
prescribed by division (A) (1) of section 3313.618 of the Revised 511
Code to qualify for a high school diploma prior to the date of 512
the administration of the assessment prescribed under division 513
(B) (1) of section 3301.0712 of the Revised Code shall not be 514
required to take that assessment. No governing authority of a 515
chartered nonpublic school shall prohibit a student who is not 516
required to take such assessment from taking the assessment. 517

(4) The assessments prescribed by sections 3301.0712 and 518

than the thirtieth day of April prior to the start of the 1080
applicable school year. The department may grant extensions 1081
valid through the 2015-2016 school year. 1082

Until June 30, 2015, the department annually shall review 1083
all staffing plans and report to the state board not later than 1084
the thirtieth day of June of each year the progress of school 1085
districts and community schools in meeting the requirements of 1086
this section. 1087

(K) The department of education shall designate one or 1088
more staff members to provide guidance and assistance to school 1089
districts and community schools in implementing the third grade 1090
guarantee established by this section, including any standards 1091
or requirements adopted to implement the guarantee and to 1092
provide information and support for reading instruction and 1093
achievement. 1094

Section 2. That existing sections 3301.0711, 3301.163, and 1095
3313.608 of the Revised Code are hereby repealed. 1096
