Section 201.10. All items in the sections of this act	4

designated fund. For all operating appropriations made in these	7	
sections, those in the first column are for fiscal year 2020 and	8	
those in the second column are for fiscal year 2021. The		
operating appropriations made in this act are in addition to any		
other operating appropriations made for the FY 2020-FY 2021

#### INDOOR ENTERTAINMENT VENUES

The foregoing appropriation item 195642, Indoor18Entertainment Venues, shall be used by the Development Services19Agency to provide grants to indoor entertainment venues impacted20by the COVID-19 pandemic. Grants shall be awarded in amounts of21\$10,000, \$20,000, and \$30,000. Awards shall be based on factors22such as demonstrated loss of revenue due to canceled events or23performances.24

NEW BUSINESS RELIEF GRANT

The foregoing appropriation item 195667, New Business Relief Grant, shall be used by the Development Services Agency to provide relief grants of \$10,000 for new businesses in this state opening after January 1, 2020.

CORONAVIRUS RELIEF - SMALL BUSINESS GRANT

The foregoing appropriation item 195631, Coronavirus31Relief - Small Business Grant, shall be used by the Development32Services Agency to provide grants of \$10,000 to all eligible33applicants who applied for grants under the Small Business Grant34Relief Program on or before December 11, 2020, but whose35requests were not funded.36

made in this act, and shall determine the form and manner in 51 which appropriation accounts shall be maintained. Expenditures 52 from operating appropriations contained in the sections of this 53 act numbered in the 200s shall be accounted for as though made 54 in H.B. 166 of the 133rd General Assembly. The operating 55 appropriations made in these sections are subject to all 56 provisions of H.B. 166 of the 133rd General Assembly that are 57 generally applicable to such appropriations. 58

Section 503.10. CORONAVIRUS RELIEF FUND REAPPROPRIATIONS

The Director of Budget and Management shall determine the60amount of the unexpended, unencumbered portion of each61appropriation item appropriated from the Coronavirus Relief Fund62(Fund 5CV1) at the end of fiscal year 2021 to be reappropriated63for the same purpose in fiscal year 2022. The amounts determined64by the Director are hereby reappropriated.65

Section 812.20.Sections 201.10, 205.10, 209.10, 215.10,66221.10, 250.10, and 503.10 of this act are exempt from the67referendum under Ohio Constitution, Article II, section 1d and68therefore take effect immediately when this act becomes law.69
