Section 250.10. Within the limits set forth in this act, 48 the Director of Budget and Management shall establish accounts 49 indicating the source and amount of funds for each appropriation 50 made in this act, and shall determine the form and manner in 51 which appropriation accounts shall be maintained. Expenditures 52 from operating appropriations contained in the sections of this 5.3 act numbered in the 200s shall be accounted for as though made 54 in H.B. 166 of the 133rd General Assembly. The operating 55 appropriations made in these sections are subject to all 56 provisions of H.B. 166 of the 133rd General Assembly that are 57 generally applicable to such appropriations. 58

#### Section 503.10. CORONAVIRUS RELIEF FUND REAPPROPRIATIONS

The Director of Budget and Management shall determine the amount of the unexpended, unencumbered portion of each appropriation item appropriated from the Coronavirus Relief Fund (Fund 5CV1) at the end of fiscal year 2021 to be reappropriated for the same purpose in fiscal year 2022. The amounts determined by the Director are hereby reappropriated.

Section 812.20. Sections 201.10, 205.10, 209.10, 215.10, 66
221.10, 250.10, and 503.10 of this act are exempt from the 67
referendum under Ohio Constitution, Article II, section 1d and 68
therefore take effect immediately when this act becomes law. 69
