#### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 201.10. All items in the sections of this act 3 numbered in the 200s are hereby appropriated as designated out 4 5 of any moneys in the state treasury to the credit of the 6 designated fund. For all operating appropriations made in these 7 sections, those in the first column are for fiscal year 2020 and those in the second column are for fiscal year 2021. The 8 operating appropriations made in this act are in addition to any 9 other operating appropriations made for the FY 2020-FY 2021 10 biennium. 11 Section 209.10. 12
