## A BILL

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 1509.228 of the Revised Code be	6
enacted to read as follows:	7
Sec. 1509.228. (A) As used in this section, "commodity"	8
means brine that is not from a horizontal well that is processed	9
or recycled to remove free oil, dissolved volatile organic	10
compounds, and other contaminants in accordance with an order,	11
permit, or approval issued under section 1509.22 or 1509.227 of	12
the Revised Code.	13
(B) A holder of a permit, order, or approval issued under	14
section 1509.22 or 1509.227 of the Revised Code who produced a	15
commodity and who is seeking to sell the commodity shall	16
demonstrate to the chief of the division of oil and gas	17
resources management that the intended use of the commodity is	18
not expected to result in damage or injury to public health,	19

(a) Documentation that the department of transportation	44
has approved the commodity for deicing or snow control;	45
(b) Documentation that the commodity, with or without a	46
corrosion inhibitor, is listed on the most recent Pacific	47
<pre>northwest snowfighters qualified products list;</pre>	48
(c) Documentation from a private certification entity	49
approved by the department of transportation.	50
(C) A commodity for which a demonstration has been made	51
under division (B) of this section is exempt from any provision	52
of the Revised Code applicable to brine, and the holder of a	53
permit, order, or approval issued under section 1509.22 or	54
1509.227 of the Revised Code who made the demonstration may sell	55
the commodity for purposes of surface application in deicing,	56
dust control, portable restrooms, or any other purpose approved	57
by the chief.	58
(D) The chief may establish reporting requirements as are	59
reasonably necessary to confirm that the production of the	60
commodity complies with the requirements of this chapter. The	
chief shall, at reasonable times, collect samples of the	62
commodity. However, the chief shall not collect more than four	63
samples of a commodity annually from a person who sells a	64
commodity as authorized under this section. The chief shall	65
provide the holder of the permit, order, or approval issued	66
under section 1509.22 or 1509.227 of the Revised Code with a	67
copy of the results of any sampling of the commodity completed	68
by the chief. The chief shall include with the copy all	69
supporting data associated with the results.	70
(E) The chief may order the suspension of the sale of a	71
commodity authorized under this section if samples of the	72

commodity show that it exceeds any chemical or radiological	73
standard established under division (B)(1) of this section. The	74
holder of the permit, order, or approval issued under section	75
1509.22 or 1509.227 of the Revised Code shall provide	76
information acceptable to the chief confirming that the	77
commodity meets those standards prior to resuming sale of the	78
commodity.	79
(F) Except as provided in this section, the chief shall	80
not adopt any rules, policies, or procedures establishing or	81
imposing additional requirements applicable to commodities that	82
have met the demonstration requirement of division (B) of this	83
section.	84
