BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 9.68 of the Revised Code be

amended to read as follows:	5
Sec. 9.68. (A) The individual right to keep and bear arms,	6
being a fundamental individual right that predates the United	7
States Constitution and Ohio Constitution, and being a	8
constitutionally protected right in every part of Ohio, the	9
general assembly finds the need to provide uniform laws	10
throughout the state regulating the ownership, possession,	11
purchase, other acquisition, transport, storage, carrying, sale,	12
other transfer, manufacture, taxation, keeping, and reporting of	13
loss or theft of firearms, their components, and their	14
ammunition. The general assembly also finds and declares that it	15
is proper for law-abiding people to protect themselves, their	16
families, and others from intruders and attackers without fear	17
of prosecution or civil action for acting in defense of	18
themselves or others. Except as specifically provided by the	19

United States Constitution, Ohio Constitution, state law, or	20
federal law, a person, without further license, permission,	21
restriction, delay, or process, including by any ordinance,	22
rule, regulation, resolution, practice, or other action or any	23
threat of citation, prosecution, or other legal process, may	24
own, possess, purchase, acquire, transport, store, carry, sell,	25
transfer, manufacture, or keep any firearm, part of a firearm,	26
its components, and its ammunition, without being required to	27
have firearm liability insurance or pay a fee for the possession	28
of the firearm, parts, components, or ammunition. Any such	29
further license, permission, restriction, delay, or process	30
interferes with the fundamental individual right described in	31
this division and unduly inhibits law-abiding people from	32
protecting themselves, their families, and others from intruders	33
and attackers and from other legitimate uses of constitutionally	34
protected firearms, including hunting and sporting activities,	35
and the state by this section preempts, supersedes, and declares	36
null and void any such further license, permission, restriction,	37
delay, or process.	38

(B) A person, group, or entity adversely affected by any 39 manner of ordinance, rule, regulation, resolution, practice, or 40 other action enacted or enforced by a political subdivision in 41 conflict with division (A) of this section may bring a civil 42 action against the political subdivision seeking damages from 43 the political subdivision, declaratory relief, injunctive 44 relief, or a combination of those remedies. Any damages awarded 45 shall be awarded against, and paid by, the political 46 subdivision. In addition to any actual damages awarded against 47 the political subdivision and other relief provided with respect 48 to such an action, the court shall award reasonable expenses to 49 any person, group, or entity that brings the action, to be paid 50 S. (1) The person, group, or entity prevails in a challenge	53	
to the ordinance, rule, regulation, resolution, practice, or	54	
action as being in conflict with division (A) of this section.	55

(2) The ordinance, rule, regulation, resolution, practice,	56	
or action or the manner of its enforcement is repealed or	57	
rescinded after the civil action was filed but prior to a final	58	
court determination of the action.	59	
(C) As used in this section:	60	
(1) The possession, transporting, or carrying of firearms,	61	
their components, or their ammunition include, but are not	62	
limited to, the possession, transporting, or carrying, openly or	63	
concealed on a person's person or concealed ready at hand, of	64	
firearms, their components, or their ammunition.	65	
(2) "Firearm" has the same meaning as in section 2923.11	66	
of the Revised Code.		
(3) "Reasonable expenses" include, but are not limited to,	68	
reasonable attorney's fees, court costs, expert witness fees,	69	
and compensation for loss of income.	70	
(4) "Firearm liability insurance" means a policy of	71	
liability insurance covering losses resulting from the use of a	72	
firearm owned by the person covered by the policy.	73	
(D) This section does not apply to either of the	74	
following:		
(1) A zoning ordinance that regulates or prohibits the	76	
commercial sale of firearms, firearm components, or ammunition	77	
for firearms in areas zoned for residential or agricultural	78

uses;	79
(2) A zoning ordinance that specifies the hours of	80
operation or the geographic areas where the commercial sale of	81
firearms, firearm components, or ammunition for firearms may	82
occur, provided that the zoning ordinance is consistent with	83
zoning ordinances for other retail establishments in the same	84
geographic area and does not result in a de facto prohibition of	85
the commercial sale of firearms, firearm components, or	86
ammunition for firearms in areas zoned for commercial, retail,	87
or industrial uses.	88
