BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 121.30 be amended and sections	7
121.34 and 121.341 of the Revised Code be enacted to read as	8
follows:	9
Sec. 121.30. As used in sections 121.30 to 121.34 121.33	10
of the Revised Code, "Spanish-speaking people" means persons who	11
possess any of the following characteristics:	12
(A) Use Spanish as their primary language;	13
(B) Regard themselves as or are regarded in their	14
community as being of Mexican, Puerto Rican, Cuban, Central	15
American, South American, Spanish, or other Spanish-speaking	16
origin or descent.	17
Sec. 121.34. (A) There is the Ohio Asian-American and	1.8

Pacific Islander affairs commission consisting of eleven voting	19	
members and four ex officio, nonvoting members as provided in	20	
divisions (C) and (D) of this section.	21	
(B) The Ohio Asian-American and Pacific Islander affairs	22	
<pre>commission shall do all of the following:</pre>	23	
(1) Gather and disseminate information and conduct	24	
hearings, conferences, investigations, and special studies on	25	
problems and programs concerning Asian-Americans and Pacific	26	
<pre>Islanders;</pre>	27	
(2) Secure appropriate recognition of the accomplishments	28	
and contributions of Asian-Americans and Pacific Islanders to	29	
<pre>this state;</pre>	30	
(3) Stimulate public awareness of the problems of Asian-	31	
Americans and Pacific Islanders by conducting a program of		
<pre>public education;</pre>	33	
(4) Develop, coordinate, and assist other public and	34	
private organizations that serve Asian-Americans and Pacific	35	
Islanders, including the conducting of training programs for	36	
<pre>community leadership and service project staff;</pre>	37	
(5) Advise the governor, general assembly, and state	38	
departments and agencies of the nature, magnitude, and	39	
priorities of the problems of Asian-Americans and Pacific	40	
<pre>Islanders;</pre>	41	
(6) Advise the governor, general assembly, and state	42	
departments and agencies on, and assist in the development and	43	
implementation of, comprehensive and coordinated policies,	44	
programs, and procedures focusing on the special problems and	45	
needs of Asian-Americans and Pacific Islanders, especially in	46	
the fields of education, employment, energy, health, housing,	47	

welfare, and recreation;	48	
(7) Propose new programs concerning Asian-Americans and	49	
Pacific Islanders to public and private agencies and evaluate	50	
for such agencies existing programs or prospective legislation		
concerning Asian-Americans and Pacific Islanders;	52	
(8) Review grants, which are made by federal, state, or	53	
private sources, and which are to be administered by the office	54	
of Asian-American and Pacific Islander affairs, and approve the	55	
administration of the grant by the office or by a subcontractor	56	
of the office;	57	
(9) Review and approve the annual report prepared by the	58	
office of Asian-American and Pacific Islander affairs;	59	
(10) Provide and coordinate the exchange of information	60	
relative to the needs of Asian-Americans and Pacific Islanders	61	
and promote the delivery of state services to such people.	62	
(C) The governor shall appoint eleven voting members to	63	
the commission with the advice and consent of the senate. The	64	
speaker of the house of representatives shall recommend to the	65	
governor two persons for appointment to the commission, the	66	
president of the senate shall recommend to the governor two such	67	
persons, and the minority leaders of the house and senate shall	68	
each recommend to the governor one such person.	69	
In addition, two ex officio, nonvoting members of the	70	
commission shall be members of the house of representatives	71	
appointed by the speaker of the house of representatives and two	72	
ex officio, nonvoting members of the commission shall be members	73	
of the senate appointed by the president of the senate. The	74	
speaker shall appoint one member of the house of representatives	75	
from among the representatives who are affiliated with the	76	

political party having a majority in the house of	77
representatives and one member of the house of representatives	78
from among the representatives who are affiliated with the	79
political party having a minority in the house of	80
representatives. The president shall appoint one member of the	81
senate from among the senators who are affiliated with the	82
political party having a majority in the senate and one member	83
of the senate from among the senators who are affiliated with	84
the political party having a minority in the senate.	85
After the governor makes initial appointments to the	86
commission, at the first organizational meeting of the	87
commission, the initial eleven voting members shall draw lots to	88
determine the length of the term each member shall serve. Three	89
shall be for a term ending one year after the effective date of	90
this section, four shall be for a term ending two years after	91
the effective date of this section, and four shall be for a term	92
ending three years after the effective date of this section.	93
Thereafter, terms of office shall be for three years, except	94
that members of the general assembly appointed to the commission	95
shall be members of the commission only so long as they are	96
members of the general assembly. Each term shall end on the same	97
day of the same month of the year as did the term which it	98
succeeds. Each member shall hold office from the date of	99
appointment until the end of the term for which the member was	100
appointed. Vacancies shall be filled in the same manner as the	101
original appointment. Any member appointed to fill a vacancy	102
occurring before the expiration of the term for which the	103
member's predecessor was appointed shall hold office for the	104
remainder of such term. Any member shall continue in office	105
after the expiration of the member's term until the member's	106
successor takes office, or until a period of sixty days has	107

elapsed, whichever occurs first.	108
(D) All voting members of the commission shall be United	109
States citizens or lawful, permanent, resident aliens. Voting	110
members shall be from urban, suburban, and rural geographical	111
areas representative of Asian-American and Pacific Islander	112
peoples with a numerical and geographical balance of the Asian-	113
American and Pacific Islander population throughout the state.	114
(E) The commission shall meet not less than six times per	115
calendar year. The commission shall elect a chairperson, vice-	116
<pre>chairperson, and other officers from its voting members as it</pre>	117
considers advisable. Six voting members constitute a quorum. The	118
commission shall adopt rules governing its procedures. No action	119
of the commission is valid without the concurrence of six	120
members.	121
(F) Each voting member shall be compensated for work as a	122
member for each day that the member is actually engaged in the	123
performance of work as a member, in an amount determined under	124
division (J) of section 124.15 of the Revised Code. No voting	125
member shall be compensated for more than one day each month. In	126
addition, each voting member shall be reimbursed for all actual	127
and necessary expenses incurred in the performance of official	128
business.	129
Sec. 121.341. The office of Asian-American and Pacific	130
<u>Islander affairs</u> is created. The office shall be accountable to	131
the commission on Asian-American and Pacific Islander affairs.	132
The chief administrator of the office shall be the director of	133
Asian-American and Pacific Islander affairs, who shall be	134
appointed by and serve at the pleasure of the commission.	135
The director, with the approval of the commission, shall	136

appoint such employees as are necessary to carry out the duties	137
of the office. The employees shall serve at the pleasure of the	138
director.	139
The office shall compile and provide information to the	140
commission about, and advise it on, solutions to the problems of	141
Asian-Americans and Pacific Islanders. The office shall execute	142
the tasks assigned to it by the commission which shall include,	143
but not be limited to, the following:	144
(A) Serve as a clearinghouse to review and comment on all	145
proposals to meet the needs of Asian-Americans and Pacific	146
Islanders that are submitted to it by public and private	147
agencies;	148
(B) Apply for and accept grants and gifts from	149
governmental and private sources to be administered by the	150
office or subcontracted to local agencies;	151
(C) Monitor and evaluate all programs subcontracted to	152
local agencies by the commission, and ensure that any grant or	153
gift is being used for the public purpose intended;	154
(D) Endeavor to assure that Asian-Americans and Pacific	155
Islanders have access to decision-making bodies in all state and	156
<pre>local governmental departments and agencies;</pre>	157
(E) Submit a full written annual report of its activities,	158
accomplishments, and recommendations to the commission;	159
(F) Establish advisory committees on special subjects as	160
needed to facilitate and maximize community participation in the	161
operation of the commission. The committees shall be composed of	162
persons representing community organizations and charitable	163
institutions, public officials, and such other persons as the	164
office determines.	165

Section 5. Within the limits set forth in this act, the	182
Director of Budget and Management shall establish accounts	183
indicating the source and amount of funds for each appropriation	184
made in this act, and shall determine the form and manner in	185
which appropriation accounts shall be maintained. Expenditures	186
from operating appropriations contained in this act shall be	187
accounted for as though made in the main operating	188
appropriations act of the 134th General Assembly. The operating	189
appropriations made in this act are subject to all provisions of	190
the main operating appropriations act of the 134th General	191
Assembly that are generally applicable to such appropriations.	192
