Opponent of H.B.22-Expanding Offense of Obstruction of Justice

Greetings Honorable Criminal Justice Committee members,

Today, I am addressing my fellow republicans as an opponent of H.B.22 and requesting an amendment to H.B. 22 due to the fact it is unconstitutional legislation. As Republicans, we are the defenders of the U.S. Constitution since 1854; when the Republican Party was formed. In 1856, former anti-slavery democrat and one of the founding members of the Republican Party Senator Charles Sumner of Massachusetts defended the inequalities and injustices of Blacks slaves in the Senate chambers.
