SB 105 Proponent Testimony

Chairman Edwards, Vice-Chair Powell, Ranking Member Upchurch, and members of the House Economic and Workforce Development Committee, thank you for allowing me to submit this correspondence as proponent testimony for Senate Bill 105. I apologize that I could not testify in person.

Ohio Senate Bill 105 is a true enhancement to creating efficiencies in government and will allow veteran, minority and women owned businesses to save time, money, and the frustration that goes along with obtaining government certifications and contracts in differing jurisdictions.

My name is Tom Pannett, recently retired from the Ohio Department of Transportation, and now working for a large law firm in Columbus. I have worked within state and local government for some time and in many capacities, and spend many years in procurement. Part of my duties and pleasure while in government was helping small, women, veteran and minority owned businesses succeed. I have engaged persons in the industry regarding this legislation such as my friends Joyce Johnson, Owner of CCI Engineering Services, DBE, WBE, EDGE Certified and John Wooldridge, Owner of Excenture Business Solutions, MBE, EDGE, DBE Certified. They assisted me in drafting this testimony.

We believe that it is beyond time for a law like SB105 to be enacted. It is frustrating for an MBE, WBE, VFBE to have to be recertified in multiple jurisdictions like Cleveland or Cincinnati after already being certified by the Ohio Department of Administrative Services for just state work. The cost and effort can be exhausting and often discouraging, and this bill will rectify that vexing experience, create opportunities for these traditionally small businesses, and allow enhanced competition for companies certified and competing in a sheltered procurement.

We thank you for generating this needed piece of legislation. After this, the community of certified business will no long have to go to jurisdiction after jurisdiction and get re-certified over and over. It is truly a win-win for all certified businesses in Ohio.
