Testimony on House Bill 227 House Government Oversight Committee October 14, 2021

Chair Hoagland, Vice Chair Terry Johnson, Ranking Member Thomas, and members of the committee, thank you for allowing my written testimony in opposition to House Bill 227.

My name is Ann Morahan. I am a proud Ohioan, having lived here for most of my 75 years. We have a state that is 34<sup>th</sup> largest by area and with a population of nearly 11.8 million, is the seventh-most populous. Ohio is the home of great presidents, astronauts, inventors, authors, scientists, and artists.

I have always been thankful to be from Ohio until I became aware of the bills our legislature is crafting. Unfortunately, Ohio's reputation is being tarnished by the numerous gun bills and suppressive bills that appear like a Whac-A-Mole arcade game.

Too many of our Republican legislators are being controlled by the NRA and their quest to push for initiatives at the state level. One of the five goals of the NRA, according to the book, <u>The</u> <u>Second amendment and the fight for Guns</u>, is on loosening concealed-carry laws. Instead of tightening gun laws, our legislators are going off the deep end to let any Tom, Dick and Mary get and use a gun without any training.
