Opposition Testimony: SB 215-Permitless Carry

Dear Chairman Wilkin, Vice Chair White, Ranking Member Brown and Committee Members,

Thank you for allowing me to provide testimony today. My name is Ruth Raynor Lapp and I am writing as a concerned citizen in opposition to SB215. I have been a consistent voter for the past 51 years in Ohio. I was licensed duck hunter in my teens, I believe there is a place for guns in our society but not a right for carrying concealed weapons without training. Vote no on this bill.

This legislation would expand the ability to carry concealed handguns to certain criminals and people charged with crimes who cannot currently obtain such a license. Ohioans have heard legislators tell us time and again that gun laws only penalize law-abiding citizens. If this is the case then there is no reason to change who may obtain a CCW license. We need laws that will encourage responsible gun ownership. Widening the net of who can carry concealed weapons, when gun violence is increasing in our state, is not a way to diminish gun violence and keep our communities safe. Concealed carry requires a background check and training because it has the potential to be far more dangerous to the public. Concealed carry is given specific licensure in order to maintain a level of safety - in who can own a gun and how they are permitted to carry it. Neither the Ohio Constitution nor the United States Constitution guarantee this right. Gun rights activists need to stop manipulating the second amendment to further their "guns everywhere" agenda. But, more importantly lawmakers need to stop caving to them at the expense of the lives of Ohioans.

SB215 would permit Ohioans without any training in the use of guns to carry a concealed handgun and sneak up on others. Handguns require more skill to use properly than a car and are at least as lethal. According to The U.S. Department of Transportation's National Highway Traffic Safety Administration (June 3, 2020), there were 38,680 fatalities from car crashes. Roughly 35,000 people are killed by guns every year. Yet prior to obtaining a driver's license, Ohio law includes classroom time, on the road practice with an instructor, 50 hours of on the road experience with a licensed citizen as well as a written test and driving exam, over a minimum of six months time. I've not heard of any legislation changing the requirement of obtaining a driver's license to zero hours and no exams. And that's for the sake of safety on the road. Legislation regarding concealed carry and who may obtain a license should be about safety. Not about rushing to put guns in the hands of more citizens and criminals.

For the first 68 years of my life I never knew anyone directly affected by gun violence. In the past 7 years sadly I know 5 including a close relative of the Dayton mass murderer.

Believing that more guns make us safer is not just realistic. If it was so, we would be the safest country in the world. Only the quick action of highly trained law enforcement brought down the Oregon district perpetrator in less than a minute yet 9 people were killed.

In Ohio, we need laws that will keep people safe. Changing the restrictions on who can obtain a CCW and then allowing anyone to carry is not the way. I ask you to please oppose SB215. Thank you for the opportunity to share my testimony with you.
