Yes to HB 248 Ohio Advocates for Medical Freedom

Good Day to the Honorable members of the Ohio House of Representatives Health Care Committee:

I am honored that Committee Member Representative Thomas West represents District 49 of which I am a constituent. His quote, April 5, 2018, "I support an individual's right to choose what goes in their bodies without fear of retribution.", leads us to count on a "yes" vote from Representative West for HB 248!

I am Darleen Moss, resident of Stark County Ohio, born in Parkersburg, West Virginia where I started my education in a segregated school, Charles Sumner. It was there that I noticed that I could buy prepared food, but not be able to eat it in the same establishment. I clearly understand what freedom meant and means when these restrictions are lifted. I came to Ohio as an excellent reader from Sumner School and was able to skip kindergarten and finish my Pre-college education at McKinley High School. The main thing I learned about Black people, in 12 years of school, was that we were slaves. I went on to graduate with a Master's Degree, eventually retiring from Canton City Schools. While I am thankful for my "secular" education, I hold most dear the fact that I have a Biblical world view, having come to Christ with a born again experience which led to mission trips here in the US and abroad, pastoring with my husband, Pastor Walter Moss, and becoming very active in the Stark County Community including leading and working with the National Day of Prayer for more than 20 years,

In maintaining religious freedom, I discovered truth about our nation, even before the lauded CRT (Critical Race Theory) agenda of 1619, I found that in April,1607 in Cape Henry, Virginia, an expedition from England landed, and there they committed to God to reach the people within the shores with the gospel of Jesus Christ, and to raise up godly generations after them. Deeper research reveals that Africans arrived in what is now the United States of America as early or earlier than the 1400's. We affirm that our Christian roots and covenant with Almighty God in 1607, 1620, and 1776, identify us.

May we be reminded of our first Amendment rights and the Ohio Constitution which you each took an oath to protect. We focus on Ohio's Constitution.

1. All men are, by nature, free and independent, and have certain inalienable rights, among which are those of enjoying and defending life and liberty, acquiring, possessing, and protecting property, and seeking and obtaining happiness and safety.

What we have seen in the recent months is not honor/ protection for the First Amendment, or Article 1 of the Bill of Rights of the Constitution of the State of Ohio, but a censoring of free speech, and an active berating, opposing freedom and love of country, and/or ignoring of these Constitutional rights. This is not acceptable. Your oaths were taken to defend and protect the freedoms of "we the people" of your constituency.

Personally, in the last months, I have been denied medical appointments 2 times...the first because I traveled to another state and was told I must quarantine for 14 days, though I had no symptoms of illness, the other for not wearing a mask (I believed from scientific data to be

unsafe) at the office of whom I thought to be a functional doctor. Prior to all this, I was erroneously told, by a former doctor, that he feared I had colon cancer, because of a reaction to a pharmaceutical pill he had prescribed. I discovered, according to John Hopkins, that the third leading cause of death is medical errors. I realize that I alone am responsible for my health and I have the absolute right to do so. The government has no right to tyrannically, unjustly, coercively mandate otherwise.

The Bible clearly says in 1 Corinthians 6:19 "What? know ye not that your body is the temple of Holy Sprit..." So why would we purposely allow the inoculation of toxic ingredients into our bodies? The ingredients of aluminum, formaldehyde, anti-freeze and aborted fetal cell lines for starters. Where are the ethical considerations for those committed to freedom and Christianity?
