RE: Ohio House Bill 248: Vaccine Choice & Anti-Discrimination Act

Chairman Lipps, Vice Chair Holmes, Ranking Member Russo, and Members of the House Health Committee, thank you for the opportunity to provide proponent testimony on House Bill 248.

My name is Julie Bentley, a life-long resident of Ohio. I lost my father and only surviving parent this past November. I believe the forced isolation and required nursing home protocols that were implemented due to COVID19 contributed to his death.

The vaccination issue has divided us when we as Ohioians and as Americans should stand united for freedom. Freedom includes the right to individually choose to elect or reject any medical procedure. I thank each of you on this committee and all who serve in a public capacity that have taken the oath of office to support the Constitution of the United States and the Constitution of Ohio.
