Dear Chairman Lipps, Vice Chair Holmes, Ranking Member Russo, and Members of the House Health Committee,

Thank you for the opportunity to provide proponent testimony on House Bill 248. My name is Mary Meyer. I have a degree in Electrical Engineering. I am a faithful Catholic, a wife, and a mother of three.

The reason I support House Bill 248 is because the free exercise clause of the US Constitution's First Amendment requires all Ohioans should have ultimate authority over their medical decisions and a right to maintain privacy regarding their decisions.

Without the passage of HB 248 the people of Ohio will be unprotected from discrimination or biweekly surveillance because they can't get the injection. It is easy to see first-hand the animosity being generated against unvaccinated individuals since they are forced to self-identify. Moreover, because of fear of retribution, any type of exemption is not being given or accepted.

Many Ohioans are already immune. We have the antibodies and as such as are more susceptible to a vaccine adverse reaction. Our natural immunity is robust and long lasting and there is no need to take on the risk of a vaccine.

Moreover, some of us are allergic to the vaccine ingredients. The CDC website states that people with a known diagnosed allergy to PEG, polyethylene glycol, another MRNA vaccine component, or polysorbate, have a contraindication to the vaccination.

Some of us take moral issue with the use of fetal tissue in the testing or manufacture of the vaccine. Each Christians has a moral duty to obey his or her own conscience. Therefore, if a Christian comes to an informed judgment that he or should not receive a vaccine, then it is their moral duty to refuse the use of medical products (including certain vaccines) that are created using a human cell line derived from abortion.

Without the exemption provisions this bill provides, the notion of a vaccine passport will lead to a class system in Ohio where segregation and prejudice will flourish. Please ensure that HB248 has an emergency provision, is heard, and PASSED promptly.
