Chairman Wiggam:

I am testifying today in favor of HB90 as an Ohio resident deeply concerned about courses of action that have been taken under the current emergency powers for almost the past year and the dire effects it is having on all of us.

Nearly a year ago, the governor unilaterally declared an unending state of emergency which he appear to have no intention of bringing to a close. The governor has essentially seized power under the guise of a public health emergency and refused to let that power go. Countless times, he has moved the goal posts with arbitrary orders that have done nothing to stop a virus. Logic suggests and science and history confirm that viruses cannot be stopped.

HB90 restores the balance of power to where it should be, between the three COEQUAL branches of government and finally gives a VOICE to the PEOPLE of Ohio via their legislators during a declared emergency. Because of COVID restrictions in higher education, my son, who is a college student, was isolated in a room for 14 days after he tested positive for COVID. No one at the school checked on him. No one gave him any treatment. They dropped food off at his door which was often cold or contained dairy which he is allergic to. They were more concerned about him "spreading" the virus than the effects of the virus on him and his life. What if he had truly been ill? What if he needed medical attention? No one seemed to care about him as a person. He was only a case because cases appear to be all that matters. Is this how we are to treat others because of one illness that has demonstrated itself not to be the monster the governor claims it to be?

I know many, many people who have had the virus and survived without being hospitalized. Based on the sheer numbers of cases to date, it is obvious that masks have done nothing to curb the spread of this virus, yet thousands upon thousands of people have survived with little inconvenience or drain upon the healthcare system. This does not even include the number of individuals who have had the virus but were never tested. There are so many people who have now been documented as a case that certainly Ohio has reached a level of herd immunity that no longer necessitates these needless, unscientifically-substantiated mandates.
