Testimony of Barbara Richey in support of H.J.R. No.1

Dear Chairman Wiggam, Vice Chairwoman John, and Ranking Member Kelly,

Thank you for the opportunity to share my thoughts as a proponent of HJR in the State and Local Government Committee.

I have recently retired from teaching to watch my first grandchild. I love this country and the freedoms we have in America! I want so much for my grandchildren to have the great opportunities that this country/republic affords. I have always believed America is the greatest place in the world. I am however increasingly concerned about the corruption and control that I am witnessing in our federal government. I feel the federal government must be reigned in for Americans to retain these freedoms! I feel that we must participate in the process of Convention of States provided for us in our constitution to save America for our children and grandchildren. I know that sounds extreme but I firmly believe if we do not step in and make changes soon we could lose our country to the radicals and tyrants in Washington. Our freedoms are fragile and little by little will be taken from us if we are not vigilant. It is frightening to think our children may not have the freedoms we have enjoyed in our lifetime.

Now we see mandates from the government to require vaccines in as many businesses as possible. Our government should not have the power to force Americans to either chose vaccines or lose their jobs. We are losing critical health care workers, highly skilled people in our workforce, military members that we have paid a lot of money to train, and many critical people in our workforce because our government wants to hold power over "we the people". I have a son who is in the age range where it is more dangerous to take the vaccine than to get Covid. He has chosen not to take the vaccine. Yet he lives in fear that he will lose his job because our government wants to control his medical decisions. I see the government trying to portray anyone who has chosen to not take the vaccines as the enemy and I worry for my son. The time has come for us to have a convention to discuss how we can give the power back to "we the people" as our founders intended. The government should be working for us not controlling our every move.

Our country has a huge problem right now with an open southern border. This is costing our country in so many ways - from drug cartels and drugs coming into our country to human trafficking to rising crime and most likely terrorism.
