## Testimony of Dale Maris in support of SJR No. 4

Chairman Peterson, Vice Chairman Cirino, Ranking Member Craig, and members of the Committee:

My name is Dale Maris from Harrison, OH, Senate District 8, Senator Louis W. Blessing, III. I serve as a Convention of States Regional Captain covering Southwest Ohio. I work with 70 Volunteer Leaders and 1,536 Volunteers along with 15,223 supporters in COS Region 5. I am a retired V.P., manager, and engineer in the Information Technology Industry.

A people free of government control, existing in a peaceful, Judeo-Christian society can advance mankind well beyond a daily fight for survival, which sadly, I've witnessed firsthand in other countries during my international business ventures.

Today, I am sickened with fear that our economic climate and culture is plagued with the notion that our freedoms and capitalistic nature are no longer of value to many in this country. My stepson will likely lose his job as an airline pilot due to his preexisting genetic health condition that makes him a bad candidate for Covid vaccine. He has already battled Covid. He has two children both looking to lose their careers as well. These are only three but very powerful examples to the destructive nature of government overreach. Such flagrant disregard for human freedom runs counter to the environment that fostered my ancestors into prosperity and love of country.

I truly believe in the Convention of States as the correct and peaceful manner to reset our country back to the free and productive country.
