Chairman Roegner, Vice Chairman McColley, Ranking Member Craig, and Members of the State and Local Government Committee:

My name is Todd Hockman and I am a life-long resident of the State of Ohio who is deeply troubled by the unilateral and wickedly authoritarian decision making of our Governor for nearly a year. As a conservative, married, Father of two residing in Bexley, OH, I refuse to accept the unconstitutional behavior of Governor DeWine and his Conspiring Associates. Moreover, I am a proud member of the Citizen Action Groups, Ohio Stands Up! (www.ohiostandsup.org) and Make Americans Free Again (www.makeamericansfreeagain.com) which filed a Claim in U.S. Federal District Court in August challenging the Governor's declaration of a "health emergency" in the State of Ohio and the unconstitutional, disproportionate and draconian response of his administration.
