> SB 30 Sponsor Testimony Senate Health Committee February 10, 2021

Chairman Huffman, Vice Chair Antani, Ranking Member Antonio and members of the Senate Health Committee. Thank you for allowing me to give testimony on Senate Bill 30.

The purpose of this bill is to designate August 31st Ohio Overdose Awareness Day and remember the lives lost to the opioid epidemic. To physically represent the impact that drug overdoses have on families and loved ones throughout the state, all state flags displayed at public institutions will be flown at half-staff.

A constituent from Berea, Ohio impacted by the opioid epidemic recently brought this idea to me to mirror the International Overdose Awareness Day, also on August 31st. While I recognize we are navigating a new public health crisis with COVID-19, the lasting impact and complicated issues associated with opioids are still heavily present in both our state and country.

August 31, 2020 was International Overdose Awareness Day and I wanted to share how this day was observed:<sup>1</sup>

- 2 worldwide virtual events took place that allowed survivors and family members to share their stories and remember those they have lost
- Ohio had 12 events statewide events hosted by various organizations and citizens in the following counties:
  - o Scioto, Clark, Lorain, Franklin (3), Ottawa, Lucas, Knox, Seneca, Richland and Erie
  - These events ranged from Narcan training, awareness walks, candlelight vigils or virtual meetings
- According to the official International Overdose Awareness Day website, 470 events took place worldwide on August 31<sup>st</sup>, 245 of those events took place across the United States

During the past couple of years, Ohio has shown a decline in the total number of overdose-related deaths per year, however, it remains the leading cause of injury-related deaths since 2007. In 2018, over 3,000 Ohioans died of unintentional drug overdoses, which is the lowest number of deaths per

year since 2015. Additionally, the percentage of fentanyl involved overdoses increased by 2%, with fentanyl involved deaths making up 73% of all overdose deaths in 2018, adding to the complexity of this issue.<sup>2</sup>

While our state is improving, Ohio ranks 5th highest in the country in overdose deaths with 35.9 per  $100,000.^3$ 

Although the mortality rate has decreased in Ohio throughout the years, during the COVID-19 pandemic there has been an increase in opioid related deaths. According to a recent Attorney General report, Ohio saw record levels of overdose deaths in the second quarter of 2020. This represents the highest rate in the last 10 years.<sup>4</sup>

As a General Assembly, we have made significant investments to support Ohioans struggling with substance use and mental health disorders by expanding recovery housing, investing in wrap-around services for K-12 students and increasing county crisis stabilization services. Ohio Overdose Awareness Day is just one small step toward eradicating this crisis from our state.
