RE: Support for HB 9 (Koehler) - Prohibiting Sales of Dextromethorphan to Minors

Dear Chairman Huffman,

On behalf of the healthcare and anti-substance abuse coalition listed below, respectfully urge your support for HB 9 – legislation which would prohibit the sale of over-the-counter (OTC) cough medicine containing the ingredient dextromethorphan (DXM) to individuals under the age of 18. We commend Representative Koehler for introducing this legislation, and we strongly support his efforts to prevent the intentional abuse of cough medicine containing DXM.

When used as directed, DXM is a safe and effective cough suppressant found in leading cough and cold products. Used by millions of Americans every year, DXM is non-narcotic, has no pain-relieving properties, and is not physically addictive. However, a small but significant number of teens admit to abusing dextromethorphan to get high. In fact, the results of the 2020 National Institute on Drug Abuse (NIDA) and University of Michigan's Monitoring the Future survey showed a slight increase in OTC cough medicine abuse. When ingested in high dosages – as much as 25 times the recommended amount – harmful side effects can occur, including confusion, dizziness, double or blurred vision, slurred speech, loss of physical coordination, vomiting, and rapid heartbeat.

Age 18 restrictions as laid out in HB 9 have proven an effective means of limiting access to the small teen population likely to abuse cough medicine. Twenty states<sup>2</sup> - including neighboring Kentucky, Michigan, Pennsylvania, and West Virginia, have passed similar legislation, giving parents greater control over the medicine to which their children have access.
