Senator Kunze,

We write to express our strong support for the restoration of \$70 million per fiscal year for public transportation funding in HB 74, the State of Ohio's biennial transportation budget.

At the Human Service Chamber, we serve 110 health and human services nonprofit organizations that understand better than most the imperative role that public transportation—especially the Central Ohio Transit Authority (COTA)—plays for hundreds of thousands of our members' clients, as well as their 14,000 employees.

COTA ensures access to jobs, healthcare, school, child care, food, legal services, housing, and much more for people of all ages: from newborn children to our communities most senior members, COTA makes our ever–growing city more accessible, and makes the social services infrastructure more accessible.

The importance of COTA to our sector is precisely why so many of our agencies' physical locations are on bus lines. And on any given year, our members spend around \$750,000 on bus passes alone.

Put another way: Without a robust public transportation system, the health and human services system would be dealt a significant blow.

And while this has long been true, the value of public transit to the Columbus Region has been amplified during the COVID-19 pandemic.

As we all strive to help one another through this crisis, our members' ability to help their clients navigate these still-turbulent times requires an untrammeled public transportation investment of \$70 million per fiscal year.

Because public transit is crucial for the recovery of Ohio's economy, we respectfully ask that the state budget maintain public transit funding at \$70 million per fiscal year.
