Ohio Hidden Heroes Scholarship Program Senate Workforce and HigherEd Committee – Andrea White Remarks

I want to thank Chair Johnson, Vice Chair Cirino, Ranking Member Martin and the members of the Workforce and Higher Education committee for the opportunity to testify on HB 569 today.

The love between a veteran and their caregiver and that caregiver and their veteran is powerful. It is something that we want to honor and respect. We want to empower both individuals through this Ohio Hidden Heroes Scholarship Program by giving the opportunity to pursue their higher education whether that's a credential or a degree without having to pay for it. This is aimed at individuals who are providing care for veterans who are completely disabled. With the online options that are available today and so much more access to higher education, this is the time to do this for our service members and their families.

Since 2001, over 20,000 U.S. services members were injured in Operating Enduring Freedom and Operation Freedom Sentinel with a majority of those injuries occurring before 2014. In the years since, much of the care for these veterans has fallen on parents, spouses, children, and siblings. This legislation will show support for veterans and the families who care for them.

The beauty of this program is that the idea came from Dayton-area residents involved with Blue Star Families and the Elizabeth Dole Foundation's Hidden Heroes cities program. Their idea inspired community, education and government leaders to take action to support our military caregivers through the Hidden Heroes Scholarship Program.

A **military caregiver** is a family member, friend, or acquaintance who provides a broad range of care and assistance for, or manages the care of, a current or former military service member with a disabling physical or mental injury or illness. These caregivers are the unsung heroes behind the heroes of our nation. They provide an invaluable

service to our country by serving those who have sacrificed and endured wounds in the protection of our freedoms. We want to recognize these individuals by encouraging Ohio colleges and universities to provide financial support as they seek to complete their education.

Ohio would be the first state to pass legislation providing educational options for caregivers of veterans who are totally disabled. Ohio truly cares about our veterans and their families and this initiative moves us even closer to our goal of making Ohio the most military and veteran friendly state in the country.

Ohio Hidden Heroes Scholarships will provide workforce development and educational opportunities for caregivers – many of whom (about 40%) already have some previous college experience. This allows them to finish a degree or certificate while caring for their veteran without worrying about how to pay for it.

The program is completely voluntary for Ohio colleges and universities. If they opt to participate, they can choose to cover one scholarship or provide for all who apply. The Ohio Department of Higher Education will develop a website to explain the scholarship and list the colleges/universities participating and share the standardized application.
